The undersigned do hereby certify that the within described real estate is their own and they are the legal owners of the same and they are not subject to any lien or claim...

It shall be the duty of the owner of each lot in this subdivision to keep the same in the same condition as it was in when the same was first surveyed and platted...

The right to enforce the within covenants shall be reserved to the owners of the lots in this subdivision and no person shall be permitted to acquire any interest in any lot...
