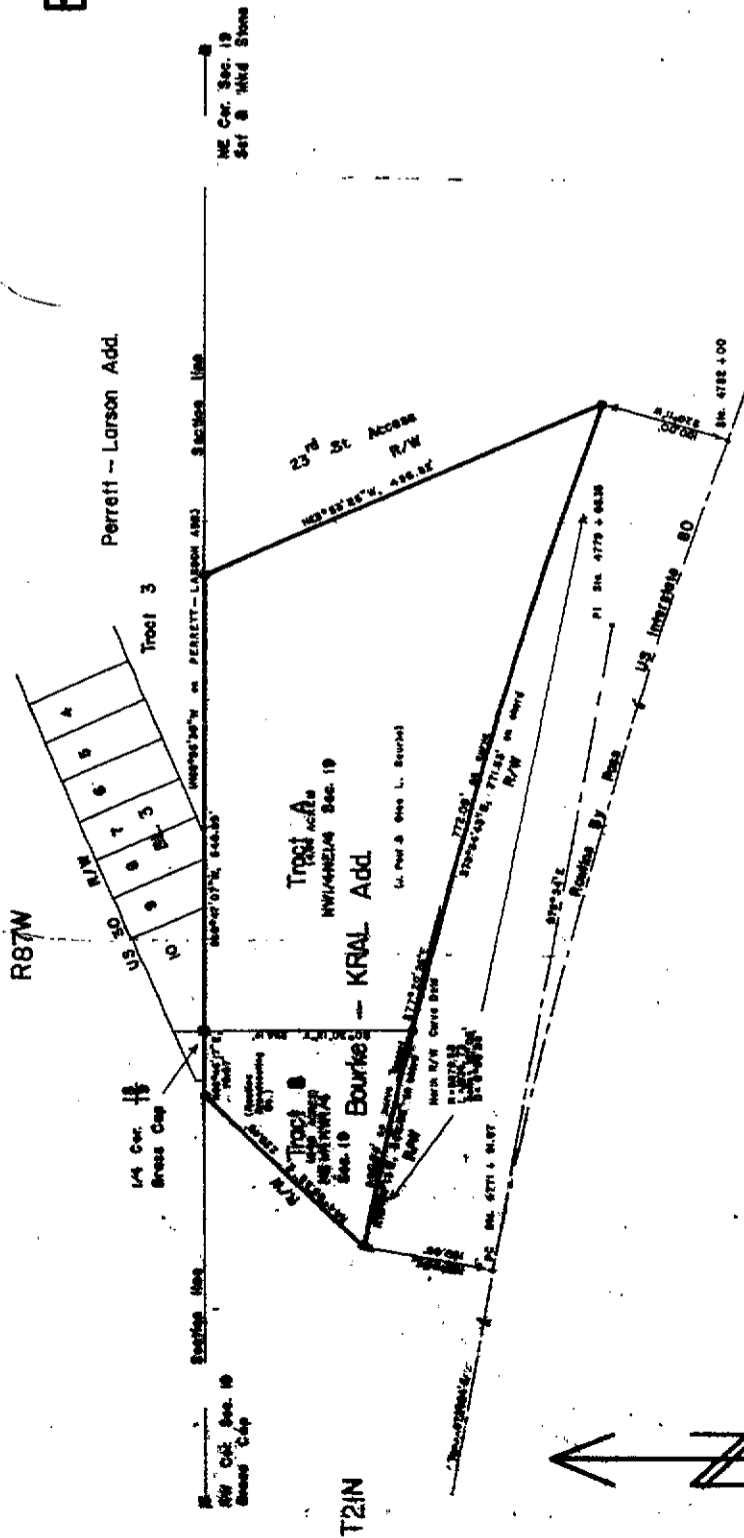


# Bourke - KRAL Addition to the City of Rawlins, Wyo.

KNOW ALL MEN BY THESE PRESENTS, that J. Paul Bourke, and Gies L. Bourke, husband and wife, of Rawlins, Wyoming, and the Rawlins Broadcasting Company, a Wyoming corporation, are the sole owners and proprietors of the real estate shown on this map and plat, hereinafter fully described, and by these presents do lay out and plat the said real estate under the name of Bourke-KRAL Addition to the City of Rawlins, County of Carbon, State of Wyoming, being Tract A and Tract B.

The legal description of the two tracts comprising this addition are as follows:

Tract A: Beginning at the North one quarter corner of Sec. 19, T21N, R87W of the 6th PM, Thence  $30^{\circ}30'37''E$ , 234.12 ft. dist. to the north right of way line of US Highway Interstate 80, Thence southeasterly along said north right of way line to the right, having a radius of 5879.58 ft., and which is tangent at its point of beginning to a straight line bearing  $87^{\circ}20'26''E$ , a distance of 772.08 ft.

Tract B: Beginning at the North one quarter corner of Sec. 19, T21N, R87W of the 6th PM, Thence  $30^{\circ}30'37''E$ , 234.12 ft. dist. to the north right of way line of US Highway Interstate 80, Thence southeasterly along said north right of way line to the right, having a radius of 5879.58 ft., and which is tangent at its point of beginning to a straight line bearing  $87^{\circ}20'26''E$ , a distance of 772.08 ft.
