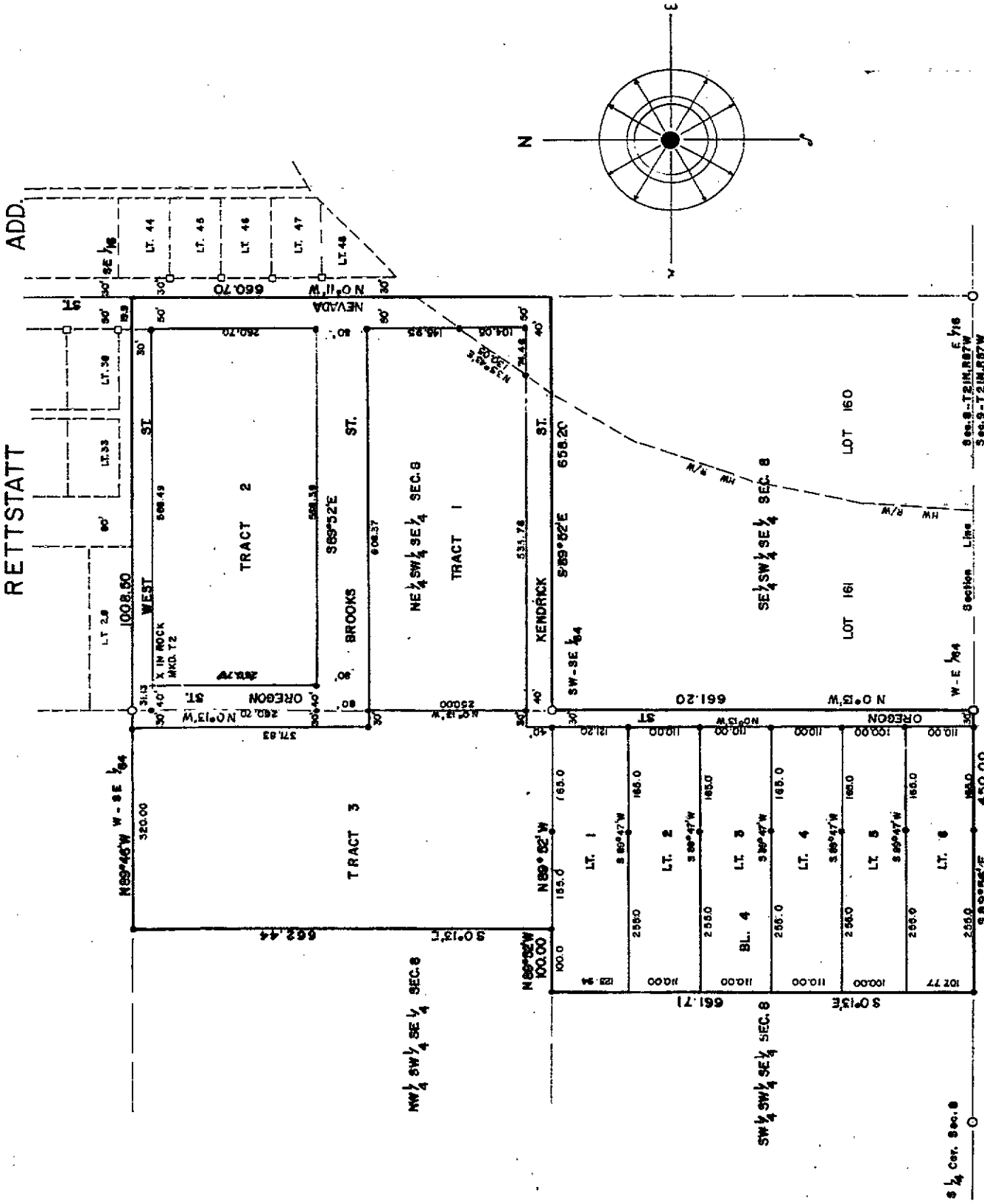

KNOW ALL MEN BY THESE PRESENTS: That H. Larsen, Inc., a Wyoming Corporation, the sole owner and proprietor of the real estate shown on this map and plat, and hereafter fully described, has laid out and platted, and by these presents does lay out and plat the said real estate, under the name of H. Larsen Addition to the City of Rawlins, Carbon County, Wyoming, being Tracts 1, 2, and 3 and Block 4, Lots 1 through 6, both inclusive, and the streets and alleys included in the description, and it hereby does dedicate in perpetuity to the use of the public all streets and alleys shown on this plat.

H. Larsen, Inc. certifies and further declares that the foregoing addition is described as follows: A tract of land situated in the Southwest Quarter of the Southwest Quarter (SW 1/4 SE 1/4) of Section Eight (8) Township Twenty-one (21) North, Range Eighty-seven (87) West of the 6th P. M., Carbon County, Wyoming, described as follows: Beginning at the Southwest Corner of the Southwest Quarter of the Southwest Quarter (SW 1/4 SW 1/4 SE 1/4) of Section Eight (8), Township Twenty-one (21) North, Range Eighty-seven (87) West of the 6th P.M.; THENCE NORTH, 661.20 feet to the Southeast Corner of the Northeast Quarter of the Southwest Quarter (NE 1/4 SW 1/4 SE 1/4) of said Sec. 8; THENCE NORTH, 660.70 feet to the Northeast Corner of said NE 1/4 SW 1/4 SE 1/4 of Sec. 8; THENCE NORTH, 1000.00 feet to a point on the North line of the Northeast Quarter of the Southwest Quarter (NE 1/4 SW 1/4 SE 1/4) of said Sec. 8; THENCE NORTH, 662.44 feet to a point on the South line of said NW 1/4 SW 1/4 SE 1/4 of Sec. 8; THENCE NORTH, 661.71 feet to a point on the South line of said NW 1/4 SW 1/4 SE 1/4 of Sec. 8; THENCE SOUTH, 450.00 feet to the point of beginning; said tract containing 22.148 Acres more or less;

as appears on this plat and map; and that the above and foregoing described addition is platted and laid out with the free consent and in accordance with the desires of the undersigned owner and proprietor.
