

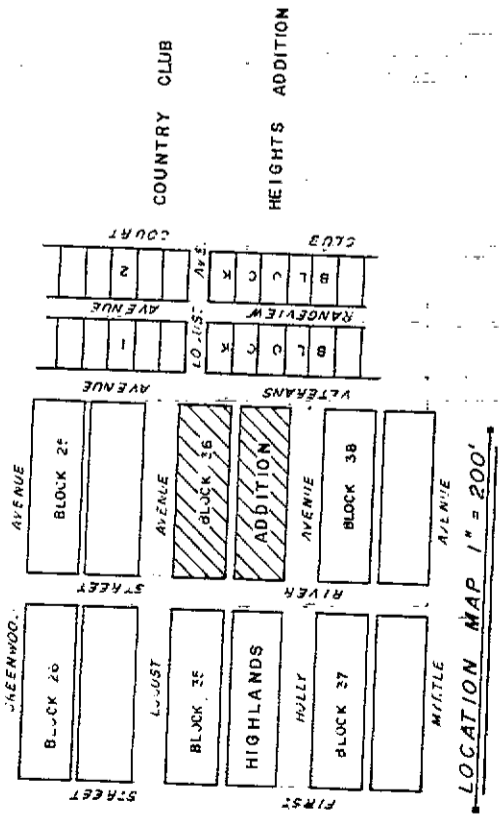
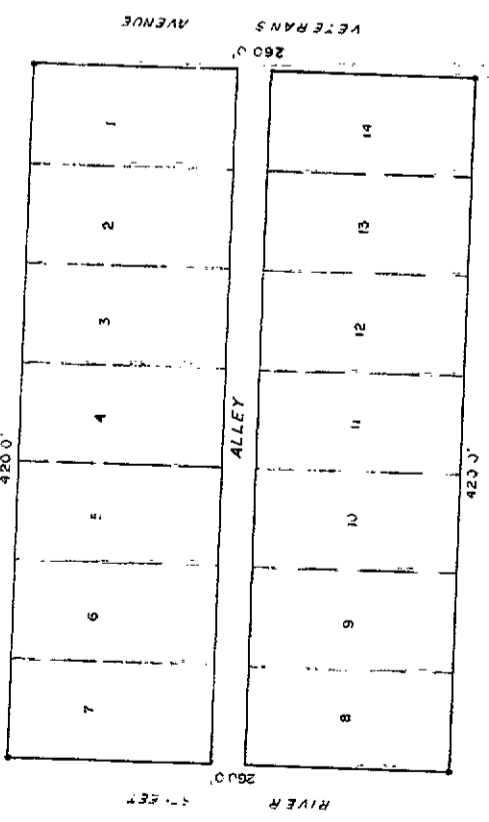

AN ORDINANCE PROVIDING THAT BLOCK NUMBERED THIRTY SIX (36) OF THE  
 HIGHLANDS ADDITION TO THE TOWN OF SARATOGA BE AND  
 THE SAME IS HEREBY DESIGNATED AS A PARK.  
 BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF SARATOGA:

SECTION 1. ALL OF BLOCK NUMBERED THIRTY SIX (36) OF THE  
 HIGHLANDS ADDITION TO THE TOWN OF SARATOGA SOMETIMES KNOWN  
 AS THE CRAWFORD ADDITION TO THE TOWN OF SARATOGA, COUNTY OF  
 CARBON, STATE OF WYOMING IS HEREBY DESIGNATED AS A TOWN PARK.  
 SECTION 2. THESE PREMISES ARE TO BE USED ONLY AS A PUBLIC  
 PARK OR PLACE OF RESORT AND RECREATION.  
 SECTION 3. THAT A PLAT OF SAID PARK IS HERETO ATTACHED AND  
 MADE A PART HEREOF BY THIS REFERENCE.  
 SECTION 4. ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT  
 HERewith ARE HEREBY REPEALED.
