



DEDICATION

KNOW ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED OWNERS AND PROPRIETORS OF A TRACT OF LAND LOCATED IN THE SE 1/4 OF THE SW 1/4 AND THE SW 1/4 OF THE SE 1/4 OF SECTION 5 AND THE NW 1/4 OF THE NE 1/4 OF SECTION 8, TOWNSHIP 22 NORTH, RANGE 78 WEST, SIXTH PRINCIPLE MERIDIAN, CARBON COUNTY, WYOMING, DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT A POINT ON THE SOUTH LINE OF SAID SECTION 5 THAT IS 60.0 FEET EASTERLY, MEASURED AT RIGHT ANGLES FROM THE NORTHERLY PROJECTION OF THE EAST LINE OF BLOCK 21 OF THE UNION PACIFIC RAILROAD COMPANY'S FIRST ADDITION TO THE TOWN OF MEDICINE BOW, WYOMING; SAID POINT OF BEGINNING COINCIDING WITH THE SOUTHWEST CORNER OF BLOCK 1, SECOND ADDITION TO THE TOWN OF MEDICINE BOW, CARBON COUNTY, WYOMING;

THENCE EASTERLY ALONG THE SOUTH LINE OF SAID BLOCK 1 125.0 FEET TO THE SOUTHEAST CORNER OF SAID BLOCK 1;

THENCE SOUTHERLY PARALLEL WITH AND 125.0 FEET EASTERLY TO THE EAST LINE OF SAID FIRST ADDITION, 750.0 FEET TO THE EASTERLY PROJECTION OF THE SOUTH LINE OF BLOCK 14 OF SAID FIRST ADDITION;

THENCE WESTERLY ALONG SAID EASTERLY PROJECTION 129.0 FEET TO THE EAST LINE OF SAID FIRST ADDITION;

THENCE WESTERLY ALONG SAID EAST LINE 760.0 FEET TO THE NORTHEAST CORNER OF SAID FIRST ADDITION;

THENCE NORTHERLY ALONG THE NORTH LINE OF SAID FIRST ADDITION 1047.0 FEET TO THE NORTHERLY PROJECTION OF THE EAST LINE OF BLOCK 16 OF SAID FIRST ADDITION;

THENCE CONTINUING WESTERLY ALONG SAID NORTH LINE 210.0 FEET, MORE OR LESS, TO THE EAST LINE OF STATE HIGHWAY 487 AS GRANTED BY AN EASEMENT DATED NOVEMBER 26, 1958 AND FILE FOR RECORD IN BOOK 398 ON PAGE 17 IN THE OFFICE OF THE CLERK OF CARBON COUNTY;

THENCE NORTHERLY ALONG SAID HIGHWAY 487 EAST RIGHT OF WAY LINE 750.0 FEET TO THE WESTERLY PROJECTION OF THE NORTH LINE OF BLOCK 5 OF SAID SECOND ADDITION;

THENCE EASTERLY ALONG SAID WESTERLY PROJECTION 270.0 FEET, MORE OR LESS, TO THE NORTHWEST CORNER OF BLOCK 5;

THENCE SOUTHERLY ALONG THE WEST LINE OF SAID BLOCK 5 300.0 FEET TO THE SOUTHWEST CORNER OF SAID BLOCK 5;

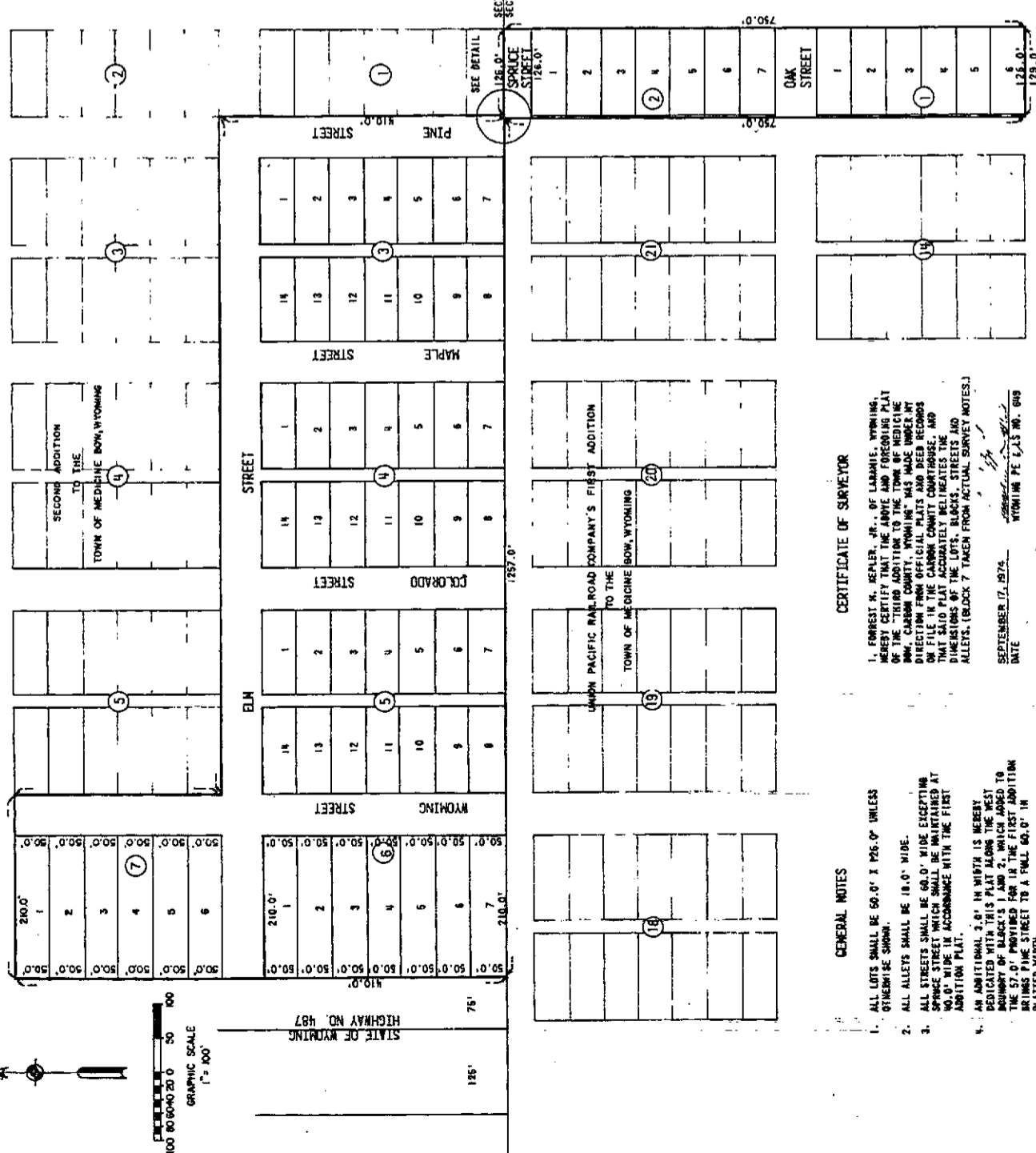

3. ALL STREETS SHALL BE 60.0' WIDE EXCEPTING SPRING STREET WHICH SHALL BE MAINTAINED AT 40.0' WIDE IN ACCORDANCE WITH THE FIRST ADDITION PLAT.
4. AN ADDITIONAL 3.0' IN WIDTH IS HEREBY DEDICATED WITH THIS PLAT ALONG THE WEST BOUNDARY OF BLOCKS 1 AND 2, WHICH ADDED TO THE 57.0' PROVIDED FOR IN THE FIRST ADDITION BRINGS PINE STREET TO A FULL 60.0' IN PLATED WIDTH.
