

# NORTHERN GAS ADDITION TO THE CITY OF RAWLINS, WYOMING DEDICATION

KNOW ALL MEN BY THESE PRESENTS: That NORTHERN GAS COMPANY, a Wyoming corporation, the sole owner and proprietor of the real estate shown and plotted on this map, hereinafter fully described, and by these presents does lay out and plat the said real estate under the name of NORTHERN GAS ADDITION to the City of Rawlins, County of Carbon, State of Wyoming, being Block 1, subdivided into Lots 1, 2, 3, 4 and Tract "A", Northern Gas Company certifies and further declares that the foregoing addition is described as follows:

A TRACT OF LAND SITUATED IN THE SE 1/4 NW 1/4 OF SECTION 17 (SEVENTEEN) AND THE SW 1/4 NW 1/4 OF SECTION 18 (EIGHTEEN), T24N, R27W OF THE 6th P.M., MORE FULLY DESCRIBED AS FOLLOWS:  
BEGINNING AT THE INTERSECTION OF THE SOUTHERLY LINE OF MAPLE STREET AND THE WESTERLY LINE OF COLORADO STREET; THENCE WESTERLY ALONG THE SOUTHERLY LINE OF MAPLE STREET A DISTANCE OF 2640 FEET; THENCE SOUTHERLY AT RIGHT ANGLES TO THE LAST NAMED COURSE ALONG THE EASTERLY LINE OF WYOMING STREET A DISTANCE OF 1320 FEET; THENCE EASTERLY AT RIGHT ANGLES TO THE LAST NAMED COURSE AND PARALLEL TO THE SOUTHERLY LINE OF MAPLE STREET A DISTANCE OF 2640 FEET; THENCE NORTHERLY AT RIGHT ANGLES TO THE LAST NAMED COURSE ALONG THE WESTERLY LINE OF COLORADO STREET A DISTANCE OF 1320 FEET TO THE POINT OF BEGINNING, SAID TRACT CONTAINING 34,848 SQUARE FEET.

The amended plat of the above-described addition is made with the free consent and in accordance with the desires of the under-signed owner and proprietor.

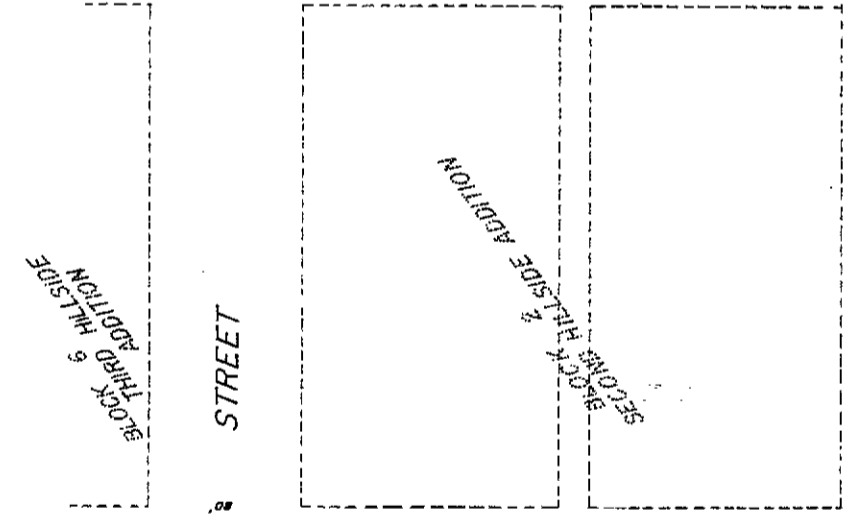

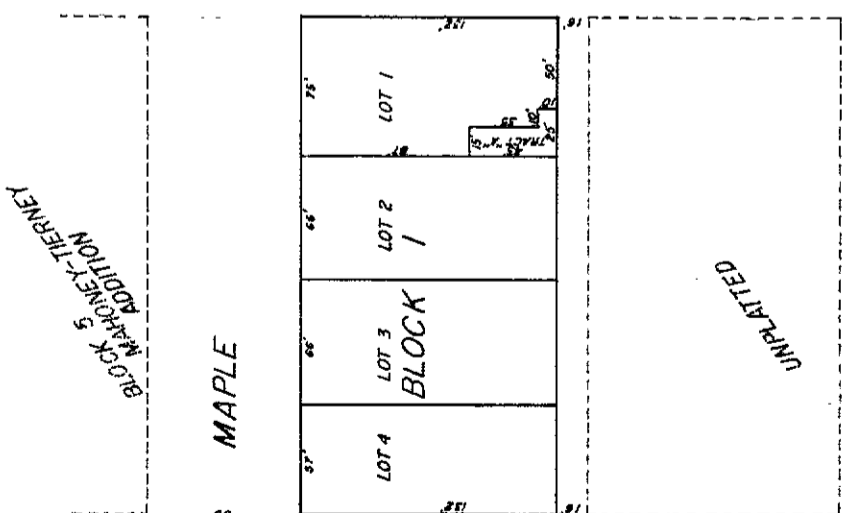

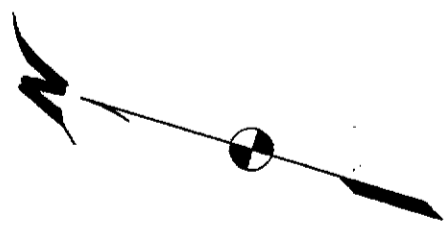
