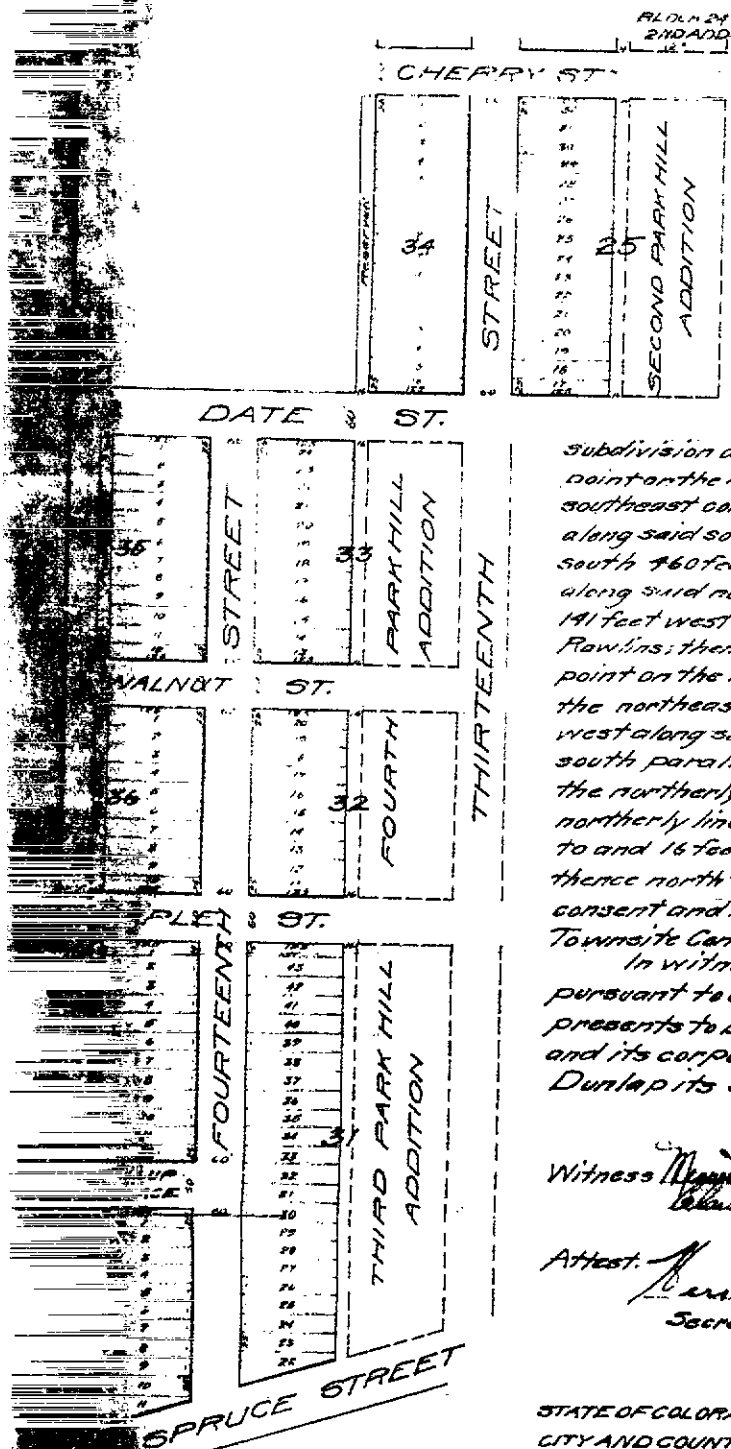


MAP OF FIFTH PARK HILL ADDITION

KNOW ALL MEN BY THESE PRESENTS

That The Rawlins Townsite Company a corporation organized and existing under, and by virtue of the laws of the State of Wyoming, being the sole owner and proprietor of the land shown on the annexed map and plat and hereafter fully described, has laid out and platted, and by these presents does lay out and plat said land under the name of Fifth Park Hill Addition to Rawlins, Wyoming, being Blocks 25, 31, 32, 33, 34, 35, 36, 37, and 38, and streets in the following description, and does hereby dedicate to the use of the public the streets and alleys shown thereon except such as are marked "Private". All streets shall have a central roadway thirty (30) feet wide and fifteen feet each side thereof to be used for sidewalk purposes.

Said Company further declares that the above and foregoing subdivision described by metes and bounds as follows: - TRACT A Beginning at a point on the north line produced of Cherry Street a distance of 141 feet west of the southeast corner of Block 24 Second Park Hill Addition to Rawlins; thence west along said south line produced of Cherry Street a distance of 326 feet; thence south 460 feet to the north line produced westerly of Date Street; thence east along said north line produced of Date Street a distance of 326 feet to a point 141 feet west of the southeast corner of Block 25 Third Park Hill Addition to Rawlins; thence north 460 feet to the place of beginning. TRACT B Beginning at a point on the north line produced of Date Street a distance of 141 feet west of the northeast corner of Block 33 Fourth Park Hill Addition to Rawlins; thence west along said north line produced of Date Street a distance of 326 feet; thence south parallel to the west line of Thirteenth Street to the intersection of the northerly line of Spruce Street produced; thence eastwardly along the northerly line produced of Spruce Street to its intersection with a line parallel to and 16 feet distant from the west line of Block 31 Third Park Hill Addition; thence north to the place of beginning, as appears on this plat is with the consent and in accordance with the desires of the undersigned The Rawlins Townsite Company the owner and proprietor thereof.

In witness whereof the said The Rawlins Townsite Company has, pursuant to a resolution of its Board of Trustees duly adopted, caused these presents to be executed in its name by Marian F. Gallup its President and its corporate seal to be hereto affixed and attested by Herschel E. Dunlap its Secretary this Fourth day of December A.D. 1922.
