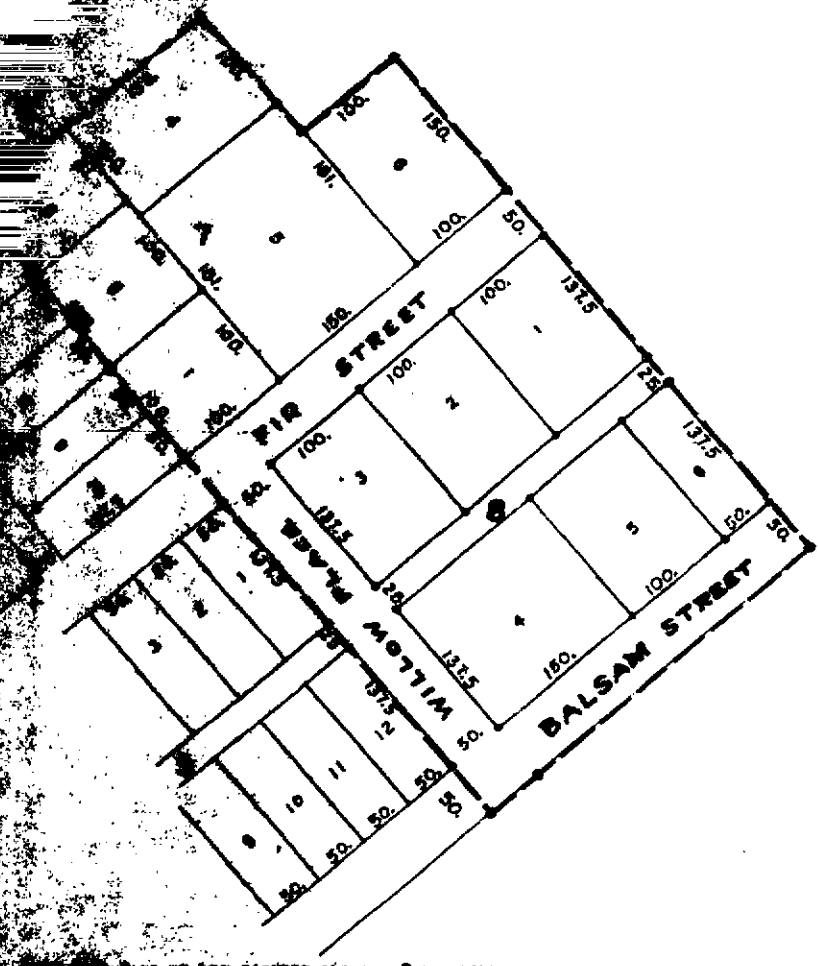


MAP OF SEIBEREN ADDITION

BEGINNING AT THE SOUTH WEST CORNER OF BLOCK FOUR (4), BASIN ADDITION  
TO THE TOWN OF ELK MOUNTAIN, WYOMING, WHICH IS ALSO THE NORTH WEST  
CORNER OF BLOCK SEVEN (7) OF THE SEIBEREN ADDITION TO THE TOWN OF ELK  
MOUNTAIN, WYOMING; THENCE AT RIGHT ANGLES IN A NORTHEASTERLY DIRECTION  
WHICH IS ALSO THE SOUTH LINE OF BLOCK FOUR (4), BASIN ADDITION THE  
HUNDRED AND EIGHTY-ONE (281) FEET; THENCE AT RIGHT ANGLES IN A SOUTH-  
EASTERLY DIRECTION TWO HUNDRED AND FIFTY (250) FEET; THENCE AT RIGHT  
ANGLES IN A SOUTHWESTERLY DIRECTION ONE HUNDRED AND THIRTY-ONE (131)  
FEET; THENCE AT RIGHT ANGLES IN A SOUTHEASTERLY DIRECTION ONE HUNDRED  
(100) FEET; THENCE AT RIGHT ANGLES IN A SOUTHWESTERLY DIRECTION FIVE  
HUNDRED AND FIFTY (550) FEET; THENCE AT RIGHT ANGLES IN A SOUTHWESTERLY  
DIRECTION THREE HUNDRED AND FIFTY (350) FEET; THENCE AT RIGHT ANGLES IN  
A NORTHEASTERLY DIRECTION FOUR HUNDRED (400) FEET TO POINT OF BEGINNING.  
HAVE LAID OUT AND PLATTED AND BY THESE PRESENTS DO LAY OUT AND PLAT THE  
REAL ESTATE AS SHOWN ON THIS MAP UNDER THE NAME OF SEIBEREN ADDITION

BLOCK SEVEN (7) AND EIGHT (8), EACH CONTAINING LOTS ONE (1) THROUGH  
SIX (6), AND SAID OWNERS HEREBY DEDICATE TO THE USE OF THE PUBLIC OR  
PUBLIC MAYS FOREVER ALL STREETS AND ALLEYS SHOWN ON THIS MAP.

ALSO THE SOUTH LINE OF BLOCK FOUR (4), BASIN ADDITION TWO HUNDRED AND  
EIGHTY-ONE (281) FEET; THENCE AT RIGHT ANGLES IN A SOUTHWESTERLY DIRECTION  
TWO HUNDRED AND FIFTY (250) FEET; THENCE AT RIGHT ANGLES IN A SOUTH-  
WESTERLY DIRECTION ONE HUNDRED AND THIRTY-ONE (131) FEET; THENCE AT  
RIGHT ANGLES IN A SOUTHEASTERLY DIRECTION ONE HUNDRED (100) FEET; THENCE  
AT RIGHT ANGLES IN A SOUTHWESTERLY DIRECTION FIVE HUNDRED AND FIFTY  
(550) FEET; THENCE AT RIGHT ANGLES IN A SOUTHWESTERLY DIRECTION THREE  
HUNDRED AND FIFTY (350) FEET; THENCE AT RIGHT ANGLES IN A NORTHEASTERLY
