

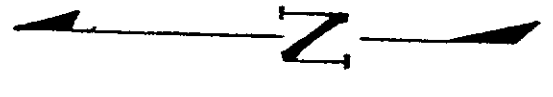
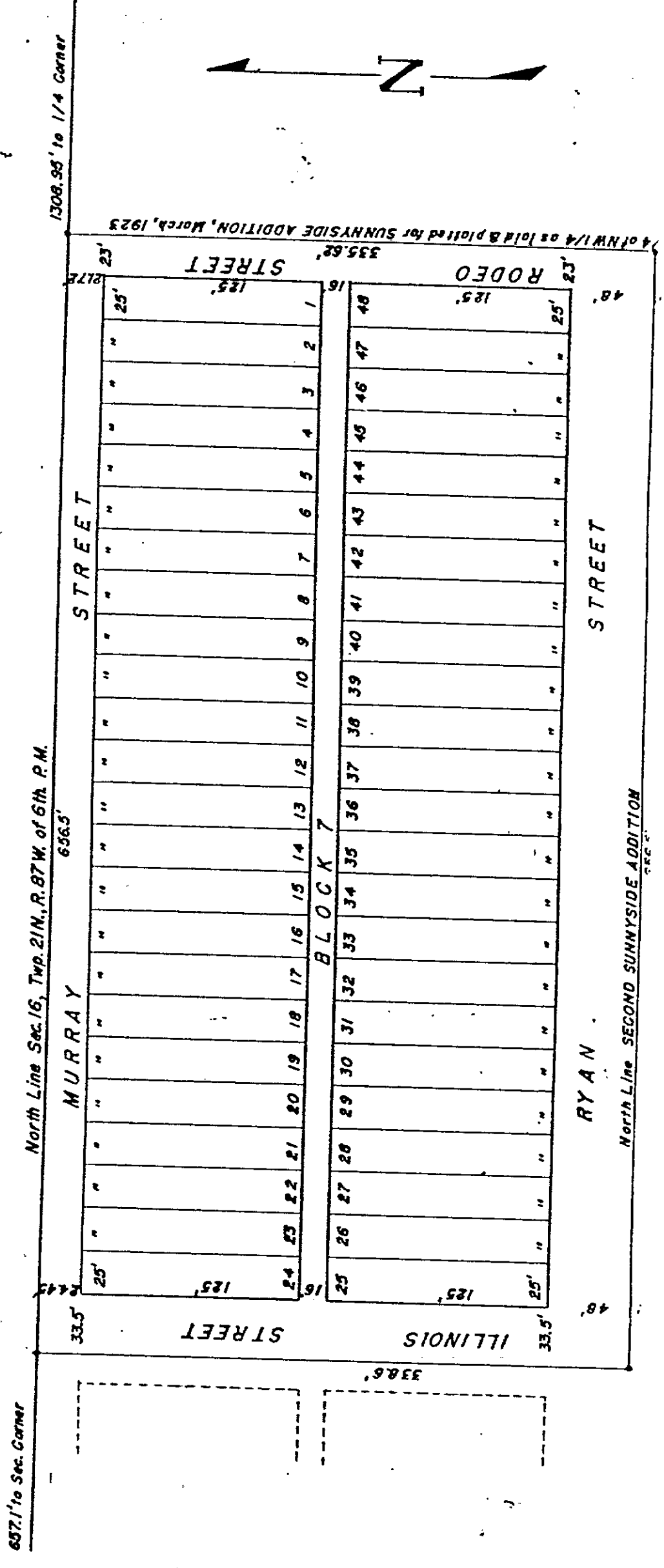
**MAP OF

THURMAN, I. W. Dinmore and Margarette Dinmore, his wife, have laid out and platted an addition to the City of Rawlins known as Third Sunnyside Addition to the City of Rawlins, consisting of Block 7, and have caused a map and plat of said addition to be prepared designating and dedicating to public use the streets, drives and the alley as more fully appear in said map and plat; and

WHEREAS, pursuant to the provisions of Section 29-206 of the Wyoming Compiled Statutes for 1945, the Mayor and Council of the City of Rawlins have heretofore approved said map and plat; and

ON THEREFORE, pursuant to the provisions of Section 29-302 of the Wyoming Compiled Statutes for 1945, be it resolved by the Mayor and Council of the City of Rawlins, Wyoming, that the dedication of the alley, drives and streets designated in said map and plat by the said I. W. Dinmore and Margarette Dinmore, his wife, and by them dedicated to public use, be and the same be hereby accepted and confirmed, and that said alley, drives and streets shall hereafter be public alley, drives and streets, and under the use and control of the City, and that the fee simple title to said alley, drives and streets be and the name in hereby accepted and confirmed to be in the said City of Rawlins.
