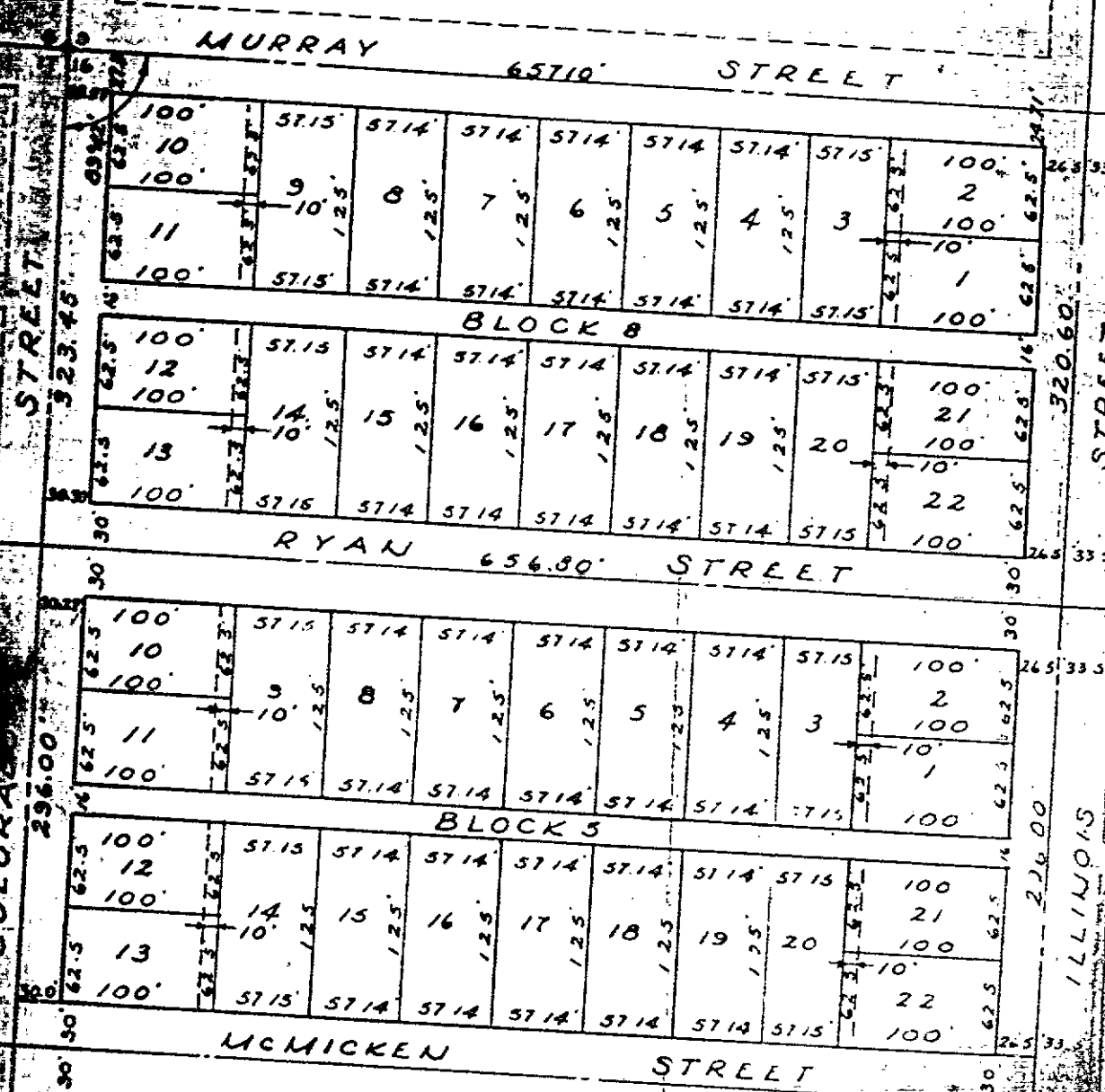


MAP OF

Freeman and Esther O. Freeman, husband and wife, sole owners of the South 1/2 of the NW 1/4 of the NW 1/4 of the NW 1/4 of Sec. 16, Twp. 21 N., R. 87 W., of the 6th P.M., Carbon County, Wyoming, have laid out and platted and by these presents do lay out and plat the real estate as shown on this map under the name of FOURTH SUNNYSIDE ADDITION to the city of Rawlins in Carbon County, State of Wyoming, being Blocks 5 and 8 and each containing Lots 1 through 22, and said owners do hereby dedicate to the use of the public as public ways forever all streets and Alleys shown on said map.

The undersigned, Grace B. Watson, S. H. Freeman and Esther O. Freeman further declare that the foregoing Addition is described as follows: Beginning at the NW corner of said Section 16; thence South along the West line of said Section a distance of 619.45 feet; thence East a distance of 656.50 feet; thence North along the West line of Third Sunnyside Addition a distance of 616.6 feet to a point on the North line of said section 16; thence West along said line a distance of 657.1 feet to the point of beginning, the total area being 932 Acres more or less the above foregoing Addition being platted with free consent and in accordance with owners and proprietors.
