AMENDMENT TO DECLARATION OF RESTRICTIVE
COVENANTS FOR DOVE ACRES SUBDIVISION
CONVERSE COUNTY, WYOMING

Pursuant to Article 2, Paragraph 3, of the Declaration of Restrictive Covenants for Dove Acres Subdivision, Converse County, Wyoming, the undersigned lot owners within such subdivision, such signatures comprising at least two-thirds (2/3) of the ownership of the total amount of lots within such subdivision, hereby amend such Declaration of Restrictive Covenants for Dove Acres Subdivision as follows:

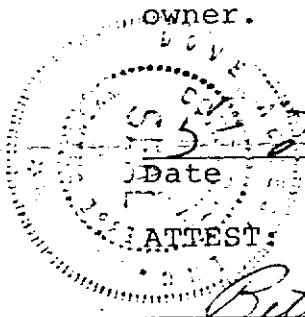
1. That the last sentence of Article 1, Paragraph 1, shall be amended to read:

All residences constructed upon said lots shall contain at least One Thousand One Hundred (1100) square feet minimum floor space.

2. All other provisions within said original Declaration of Restrictive Covenants other than that set out above shall remain in effect and unaltered in any way by this Amendment.

3. That this Amendment shall be placed of record with the Converse County Clerk as an official Amendment to those Declarations of Restrictive Covenants previously made by Declarant, Dove Acres, Inc.

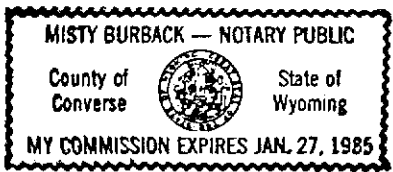

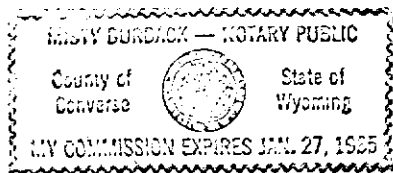
