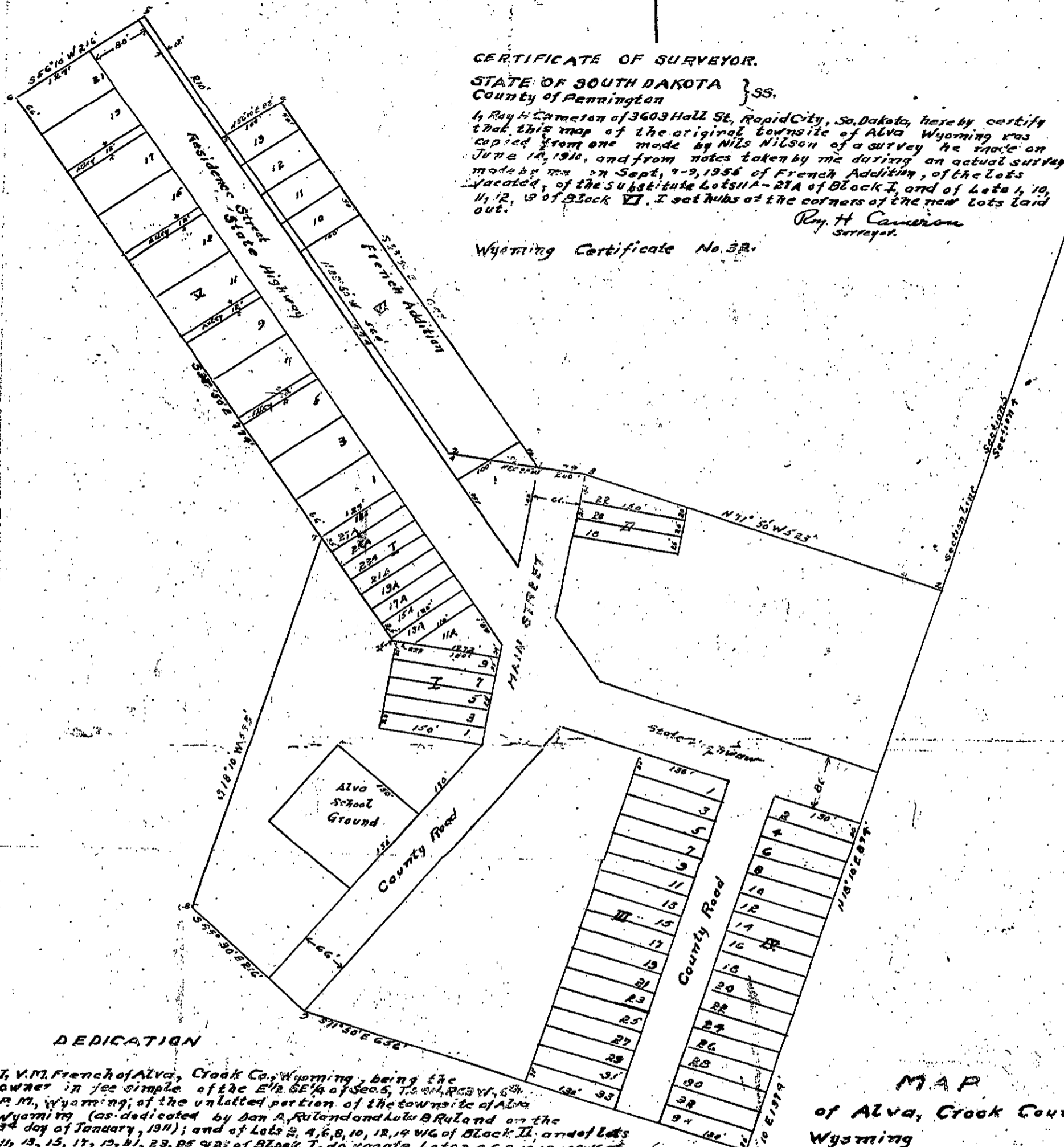
CERTIFICATE OF SURVEYOR.

DEDICATION

I, V.M. French of Alva, Crook Co., Wyoming, being the owner in fee simple of the E 1/2 SE 1/4 of Sec. 5, T. 20 N., R. 23 W., 6th P.M., Wyoming; of the unletted portion of the townsite of Alva Wyoming (as dedicated by Dan A. Ruland and Lulu Ruland on the 34 day of January, 1911); and of Lots 2, 4, 6, 8, 10, 12, 14 W 1/2 of Block II, and of Lots 11, 13, 15, 17, 19, 21, 23, 25 1/2 of Block I, do vacate Lots 2, 4, 6, 8, 10, 12, 14 W 1/2 of Block II and Lots 11, 13, 15, 17, 19, 21, 23, 25 1/2 of Block I. I dedicate Main Street to public use. I further dedicate the following tract located in NE 1/4 SE 1/4 of Section 5 - starting at the SE corner of Sec. 5, T. 20 N., R. 23 W., 6th P.M. Wyoming 90 N 18° 10' E 1374 feet along the section line between Secs. 4 & 5 to corner No. 2 of the original townsite; thence 244° 50' W 533 feet along the original townsite line to corner No. 3 of the original townsite; thence 90 N 20° 35' W 79 feet along the original townsite boundary to corner No. 1 of French Add; running thence N 60° 35' W 121 feet along boundary line of original townsite to corner No. 2 of French Add; thence N 33° 50' W 560 feet along original townsite boundary to corner No. 3 of French Add; thence N 50° 15' E 80 feet to corner No. 4 of French Add; thence S 23° 20' E 497 feet to corner No. 1 of French Add, the starting point. Containing 2.26 acres - to be known as the French Addition to the Town of Alva. I have further caused lots 11A, 13A, 15A, 17A, 19A, 21A, 23A, 25A & 27A of Block I and Lots 1, 10, 11, 12 & 13 of Block II to be laid out. I do here by state that the above and foregoing dedication and vacation is with my free consent and in accordance with my desires as the owner of said premises.
