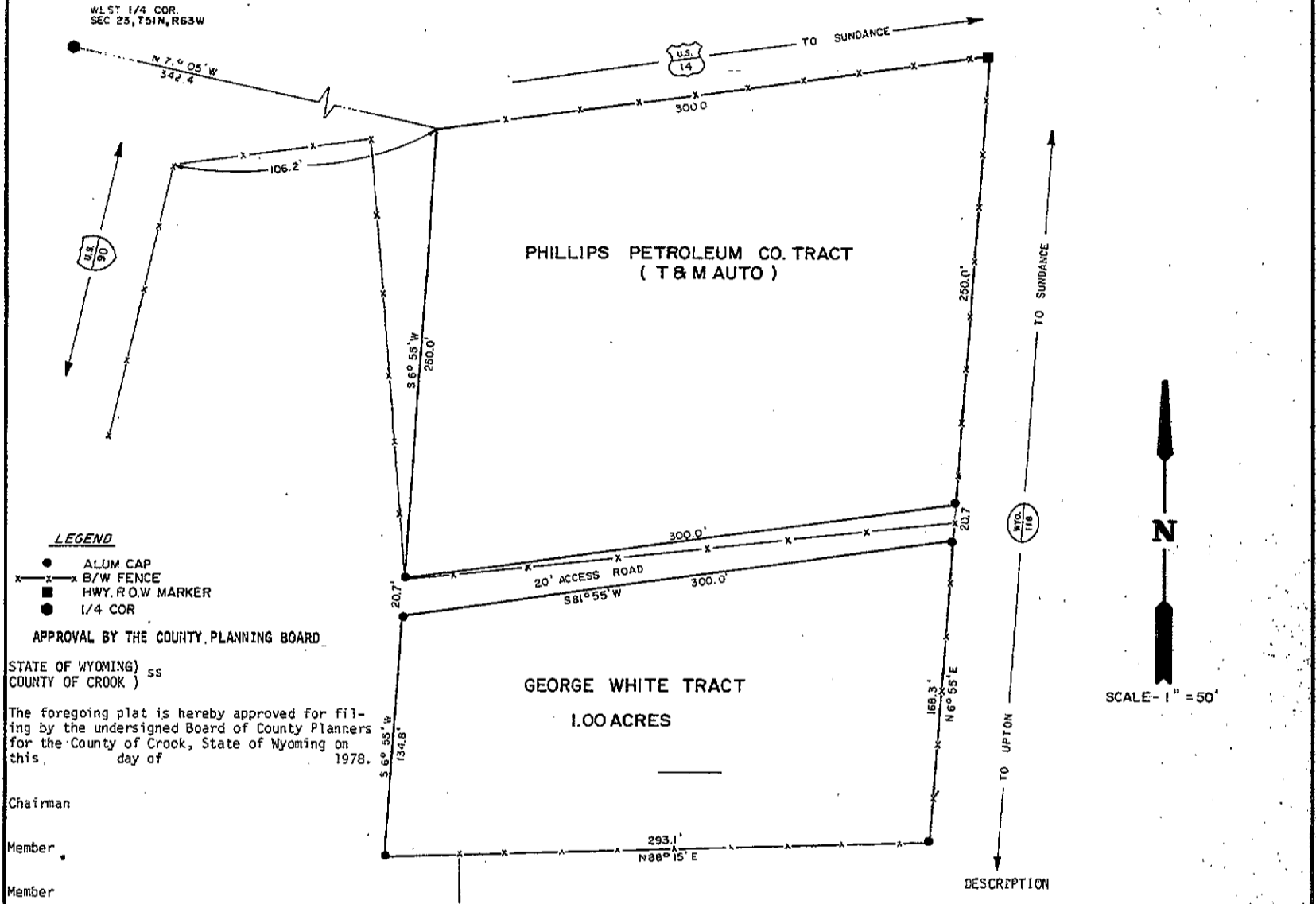

DESCRIPTION
 A tract of land in the NW 1/4 SW 1/4 of Section 23, Township 51 North, Range 63 West of the Sixth Principal Meridian, Crook County, Wyoming, being more particularly described as follows:

Commencing at the West 1/4 corner of Section 23, T51N, R63W, run S 71° 05' E for 342.4 feet to a point on the South Right-of-way boundary of U.S. Highway No. 14;
 Thence S 06° 55' W for 270.7 feet to the Northwest corner and the point of beginning;
 Thence continuing S 06° 55' W for 134.8 feet to the Southwest corner;
 Thence N 88° 15' E along the existing fence line for 293.1 feet to the Southeast corner;
 Thence N 06° 55' E along the West Right-of-way boundary of State Highway No. 116 for 168.3 feet to the Northeast corner;
 Thence S 81° 55' W parallel to and 20 feet Southerly of the South boundary of the Phillips Petroleum Tract for 300.0 feet to the Northwest corner and the point of beginning;
