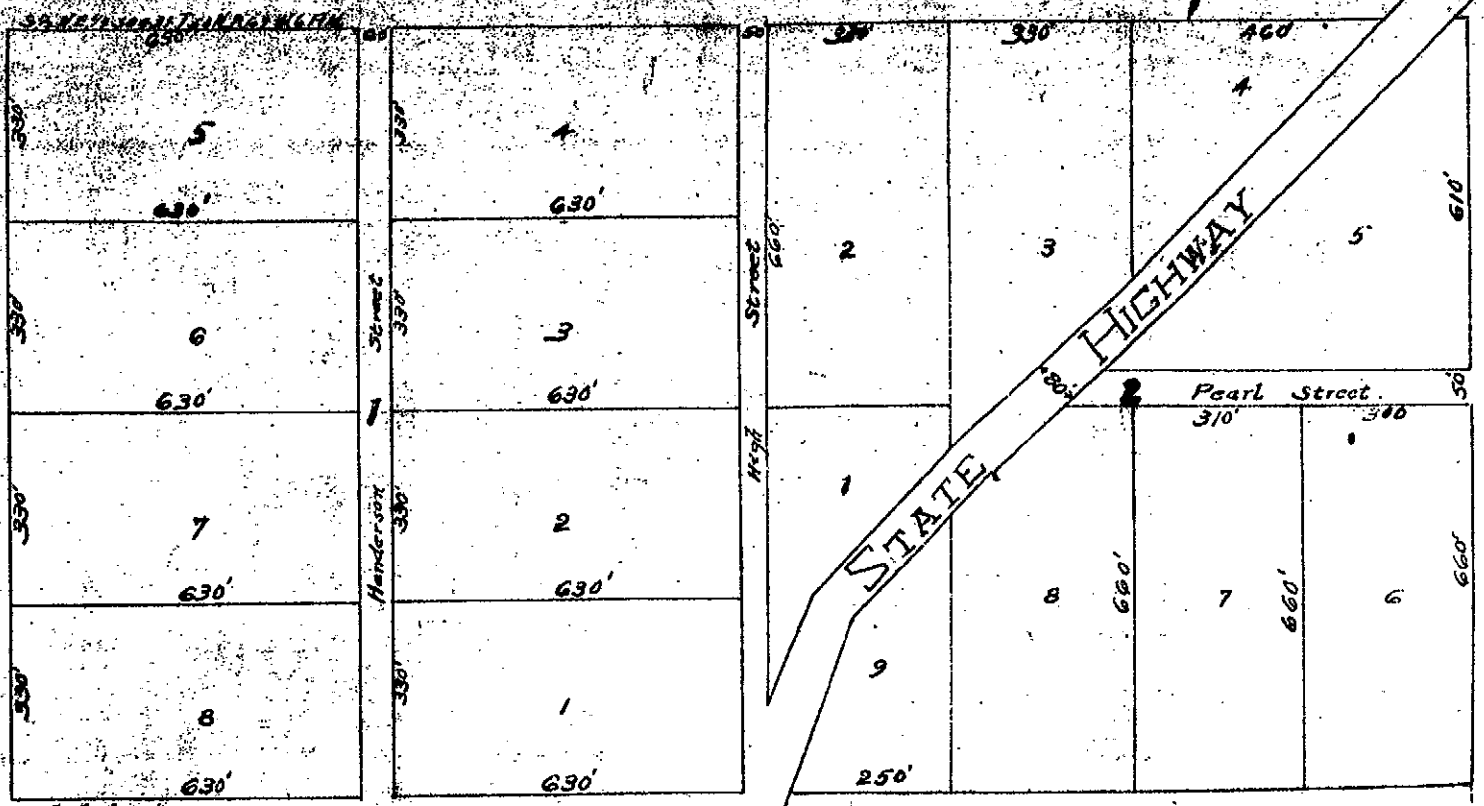

I, C.E. Russell, hereby certify that on the 10th day of  
 September A.D. 1920 I surveyed the Henderson Addition to  
 Moorcroft, Crook Co., Wyoming, which comprises the South  
 half of the Northeast quarter of section Thirty one (31) Township  
 Fifty (50) North of Range Sixty seven (67) West of the Sixth  
 Principal Meridian, and more particularly described as  
 follows:

Commencing at a point 2640 feet north of government  
 rock at Southeast corner of said Section Thirty-one (31) thence  
 running West at right angles 2640 feet, thence North 1320 feet,  
 thence East 2640 feet thence South 1320 feet to point of starting.  
 That the accompanying map was made from notes taken during  
 said survey drawn to a scale of 200 feet to an inch on which  
 are indicated in figures the width of streets and dimensions  
 of lots in feet, each lot and block bears its own number. That  
 oak or pine stakes are driven well into the ground at front  
 corners of each lot.
