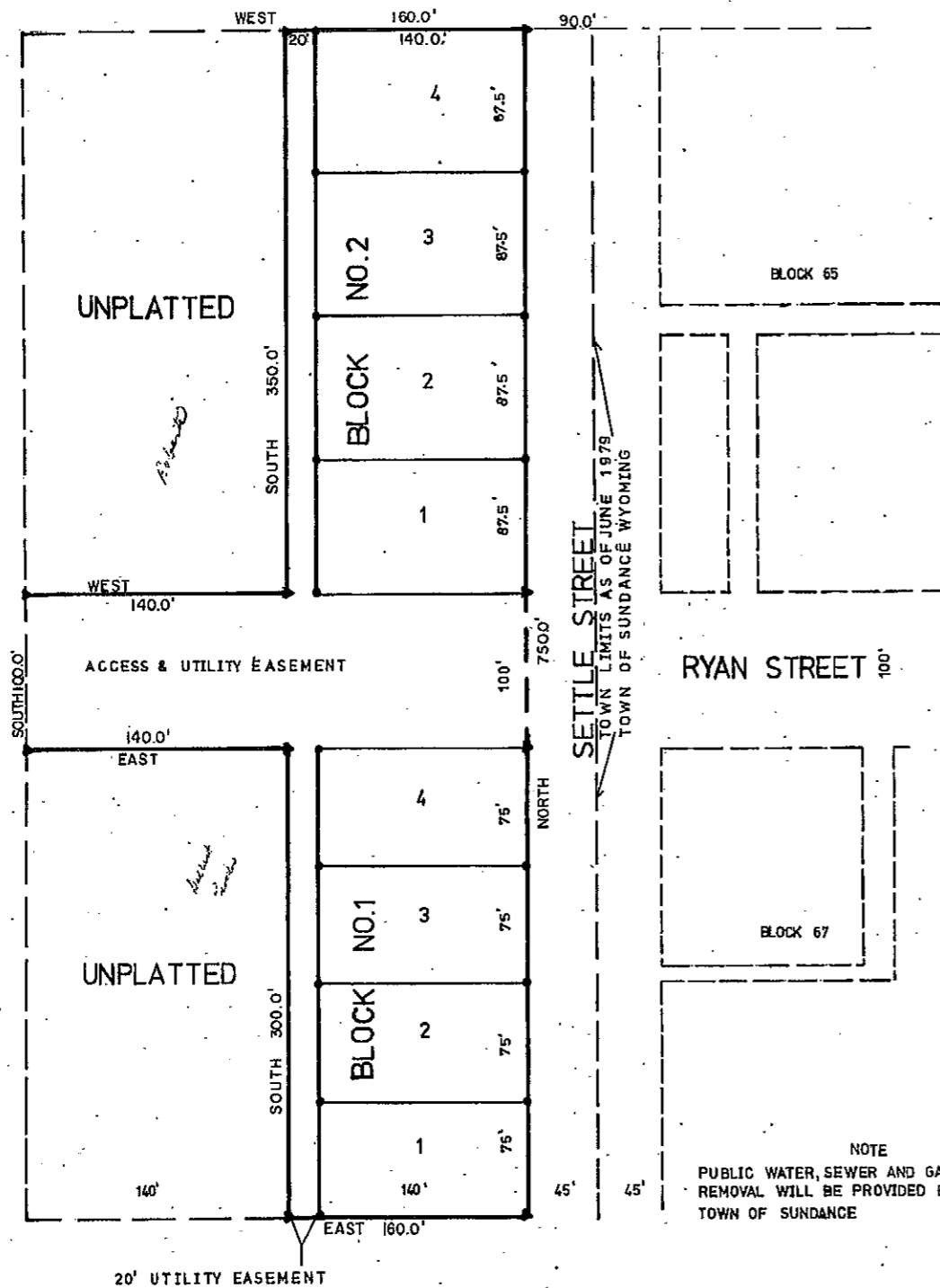

A TRACT OF LAND LYING IN THE SW 1/4 SE 1/4 OF SECTION 14, T.51N., R.63W, OF THE SIXTH PM BEING PORTIONS OF BLOCKS 66 AND 68 OF ALDEN ADDITION TO THE TOWN OF SUNDANCE, WYOMING, AS VACATED AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT WHICH LIES 900 FEET FROM THE NORTHWEST CORNER OF BLOCK 65 ALDEN ADDITION TO THE TOWN OF SUNDANCE, WYOMING,
