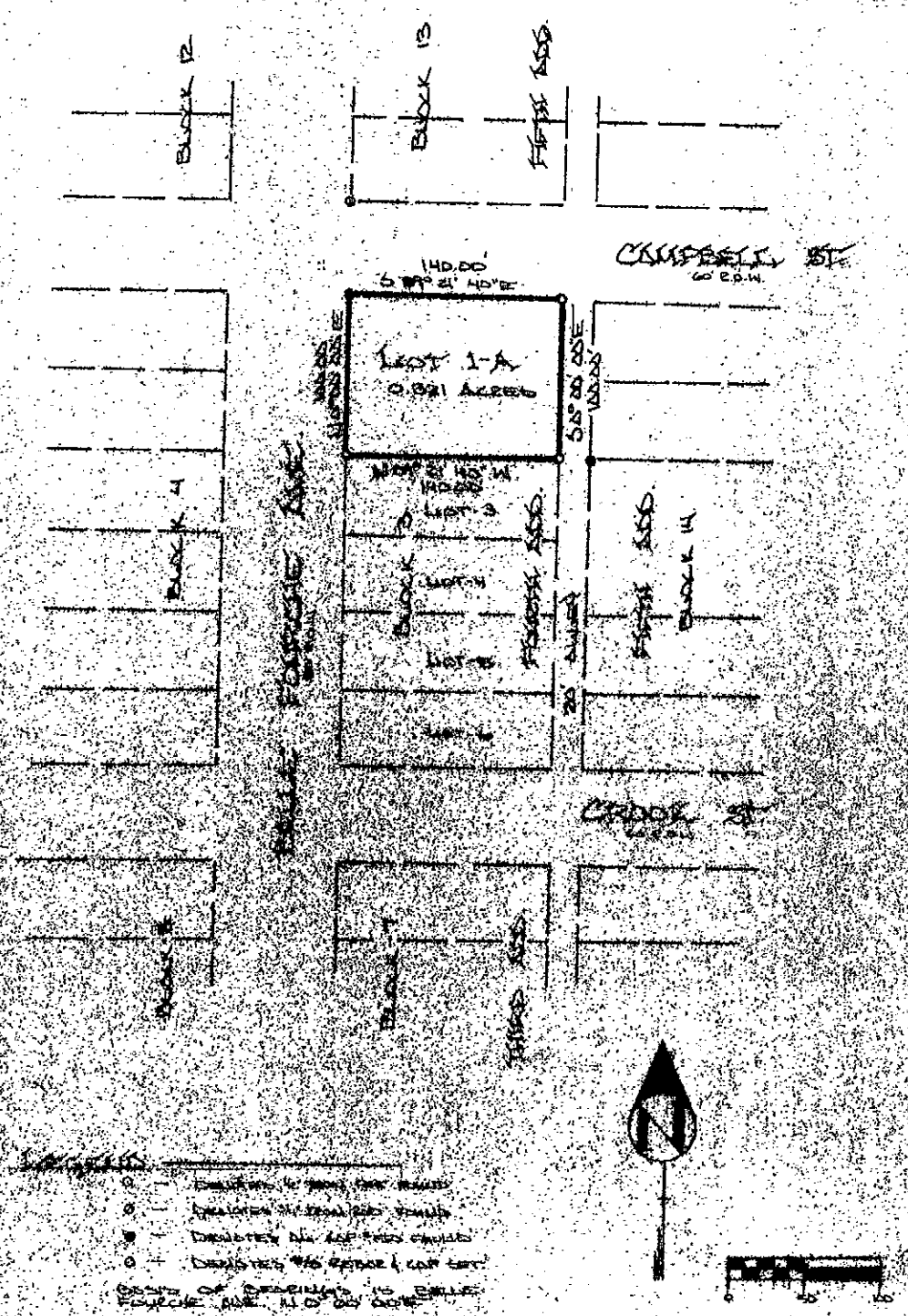

OF WYOMING.

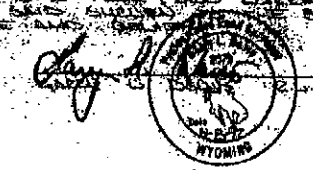
