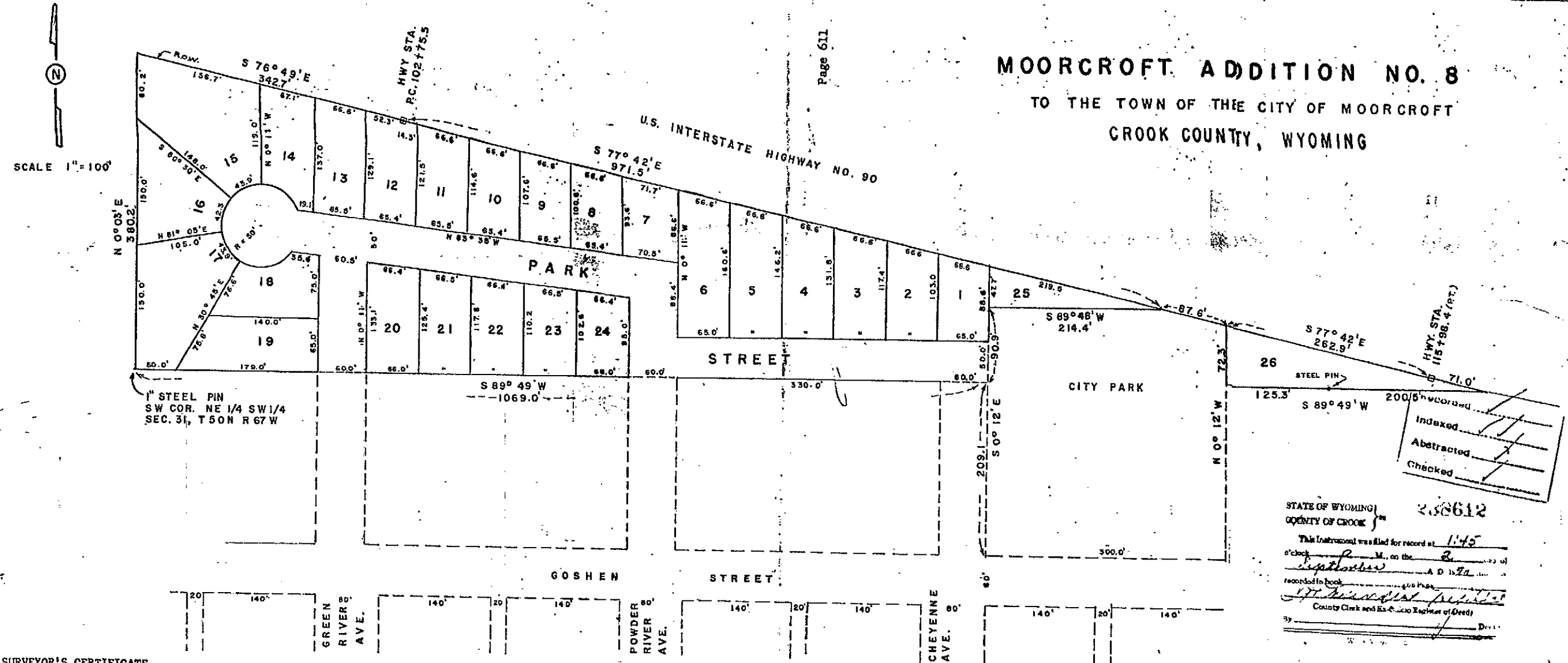

### CERTIFICATE OF DEDICATION: STATE OF WYOMING - COUNTY OF CROOK

The foregoing subdivision of the following described land to wit:

A tract of land comprising that portion of the NE 1/4 SW 1/4 & NW 1/4 SE 1/4 of Section 31, T50N, R67W of the 6th Principal Meridian, Crook County, Wyoming, lying South of Interstate Highway No. 90, less a portion for the Town of Moorcroft Park (Noonan Park), and being more particularly described as follows:

Commencing at a steel pin at the Southwest corner of the NE 1/4 SW 1/4 of Sec. 31, T50N, R67W, the Southwest corner of this tract and the point of beginning; thence N 0°03' E for 380.2 feet to intersect the South Right-of-Way boundary of Interstate Highway No. 90; thence Southeast along said Right-of-Way along a curve which has a chord which bears S 76°49' E for 342.7 feet to a 6" X 6" concrete marker stamped "P.C. 102+75.5"; thence continuing along said Right-of-Way S 77°42' E for 971.5 feet to intersect the North boundary of the Town of Moorcroft Park; thence continuing S 77°42' E for 87.6 feet to the East boundary of said Park; thence continuing S 77°42' E for 262.9 feet to a 6" X 6" concrete marker stamped "P.T. 115+98.4"; thence continuing S 77°42' E along the Highway Right-of-Way for 71.0 feet to the East corner; thence S 89°49' W for 200.5 feet to a steel pin on the South boundary of the NW 1/4 SE 1/4; thence continuing S 89°49' W for 125.3 feet to intersect the East boundary of the Town of Moorcroft Park; thence N 0°12' W for 72.3 feet to intersect the South Right-of-Way boundary of Interstate Highway No. 90; thence N 77°42' W for 87.6 feet to the North boundary of the Town of Moorcroft Park; thence S 89°48' W along the North boundary of the Park for 214.4 feet; thence S 0°12' E along the West boundary of the Park for 90.9 feet to the South boundary of the NE 1/4 SW 1/4 of Sec. 31; thence S 89°49' W for 1069.0 feet to the Southwest corner, and the point of beginning. Said tract contains 6.71 acres, more or less. Bearings as given are based on Wyoming Highway Department Datum on Interstate Highway No. 90.
