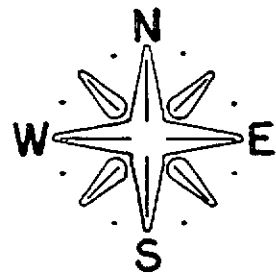
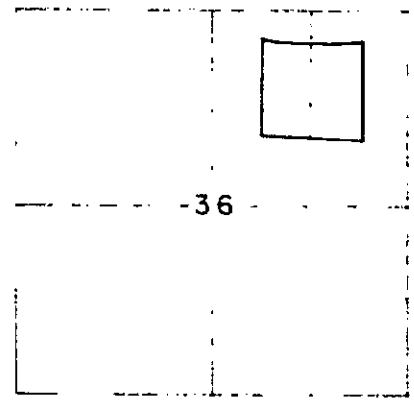


PLAT OF
