That part of the Southwest Quarter of the Southwest Quarter of Section 31, Township 50 North, Range 67 West of the Sixth Principal Meridian, Crook County, Wyoming, described as follows:

Commencing at a point 650 feet, S 89°57' W from the Northeast corner of the SW 1/4 SW 1/4 of said Section 31; thence S 89°57' W for a distance of 579.4 feet; thence S 00°00' W for a distance of 3.57 feet to intersect the Northerly right-of-way of U. S. Highway No. 16; thence S 55°24' E for a distance of 105.0 feet to the point of curvature of a curve at Highway Station 334 + 73.9; thence Southeasterly along the Northerly curving right-of-way of said U. S. Highway No. 16 for a distance of 649.5 feet to the point of tangency of said curve at Highway Station 340 + 95.4; thence S 43°36' E for a distance of 33.44 feet; thence N 00°00' E for a distance of 489.11 feet to the point of beginning.
