I, DONALD R. HORTON OF TORRINGTON, WYOMING, DO HEREBY CERTIFY THAT THIS PLAT OF BLOEDORN 4TH ADDITION WAS MADE FROM NOTES TAKEN DURING AN ACTUAL FIELD SURVEY MADE BY ME ON MARCH 30, 1978, AND THAT IT CORRECTLY REPRESENTS THE LOTS, BLOCKS, STREET AND ALLEY AS MARKED ON THE GROUND BY 5/8" IRON REBAR WITH AN ALUMINUM CAP, AND THAT THE LANDS EMBRACED IN THIS SUB-DIVISION ARE THAT PART OF THE N1/2, SECTION 10, T24N, R61W, 6th P.M., GOSHEN COUNTY WYOMING, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE SOUTH BOUNDARY OF EAST 22ND AVENUE BEING EAST, A DISTANCE OF 130 FEET FROM THE INTERSECTION OF THE SOUTH BOUNDARY OF EAST 22ND AVENUE AND THE EAST BOUNDARY OF EAST H STREET, TOWN OF TORRINGTON, WYOMING, THENCE S00°43'W, A DISTANCE OF 660 FEET TO A POINT ON THE NORTH BOUNDARY OF EAST 20TH AVENUE OF THE TOWN OF TORRINGTON, WYOMING; THENCE ALONG SAID NORTH BOUNDARY OF EAST 20TH AVENUE, WEST, A DISTANCE OF 310 FEET; THENCE ALONG THE EAST BOUNDARY OF A DEDICATED ALLEY, N00°43'E, A DISTANCE OF 660 FEET TO A POINT ON THE SOUTH BOUNDARY OF EAST 22ND AVENUE; THENCE ALONG THE SOUTH BOUNDARY OF EAST 22ND AVENUE OF THE TOWN OF TORRINGTON, WYOMING, EAST, A DISTANCE OF 310 FEET TO THE POINT OF BEGINNING, SAID PARCEL CONTAINS 4.7 ACRES, MORE OR LESS.
