I, DONALD R. HORTON, EMPLOYED BY L.H. ENGINEERING AND LAND SURVEYING OF TORRINGTON, WYOMING, DO HEREBY CERTIFY THAT THIS PLAT OF BLOEDORN 5th ADDITION WAS MADE FROM NOTES TAKEN DURING AN ACTUAL FIELD SURVEY ON SEPTEMBER 19, 1980, AND THAT IT CORRECTLY REPRESENTS THE LOTS, BLOCKS, STREETS AND ALLEY AS MARKED ON THE GROUND BY 1/2" IRON RE-BAR WITH AN ALUMINUM CAP MARKED PELS 677, AND THAT THE LANDS EMBRACED IN THIS SUB-DIVISION ARE THAT PART OF THE NE1/4 AND THE SE1/4, SECTION 10, T21N, R61W, OF THE 6th P.M., GOSHEN COUNTY, WYOMING, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT THAT IS EAST ALONG THE NORTH LINE OF EAST 20th AVENUE, A DISTANCE OF 130.0 FEET FROM THE POINT OF INTERSECTION OF THE NORTH LINE OF EAST 20th AVENUE AND THE EAST LINE OF EAST 19th STREET, TOWN OF TORRINGTON, WYOMING; THENCE NORTH 90°13'1" PARALLEL WITH EAST 19th STREET OF THE TOWN OF TORRINGTON, A DISTANCE OF 1277.81 FEET TO THE POINT OF INTERSECTION OF THIS LINE WITH THE SOUTH RIGHT-OF-WAY BOUNDARY OF THE NORTH PLATTE DITCH; THENCE S 16°05'20" E ALONG THE SOUTH RIGHT-OF-WAY BOUNDARY OF THE NORTH PLATTE DITCH, A DISTANCE OF 125.18 FEET TO A POINT THAT IS ON A LINE PARALLEL WITH AND 310 FEET EAST OF THE FIRST COURSE OF THIS DESCRIPTION; THENCE S00°13'1" ALONG A LINE PARALLEL WITH THE FIRST COURSE OF THIS DESCRIPTION, A DISTANCE OF 982.91 FEET TO THE POINT OF INTERSECTION OF THIS LINE WITH THE NORTH LINE OF EAST 20th AVENUE; THENCE WEST ALONG THE NORTH LINE OF EAST 20th AVENUE A DISTANCE OF 310.0 FEET TO THE POINT OF BEGINNING AND CONTAINING 8.04 ACRES MORE OR LESS.

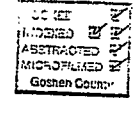
