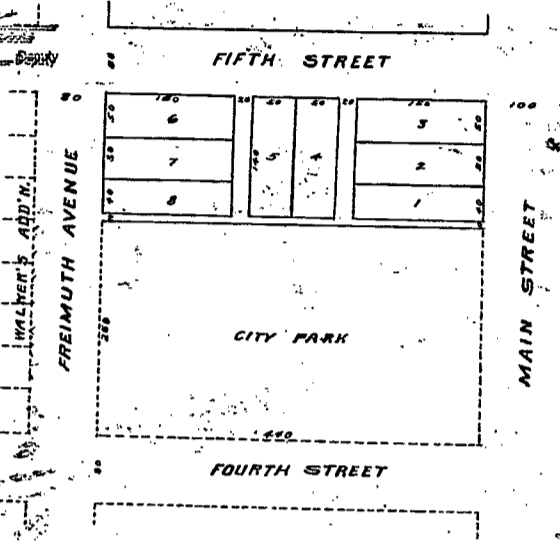

### DEDICATION

THIS CERTIFIES that the Goshen Farmers Union Co-op. Supply Assn., a corporation duly organized and existing under the laws of the State of Wyoming, and authorized to do business in said State, is the owner in fee of the following described tract of land situated in the Town of Lingle, Goshen County, Wyoming, to-wit:

A tract of land situated in the Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4) of Section Eighteen (18), Township Twenty-five (25) North, Range Sixty-two (62) West of the 6th P.M., and further described as follows:

Beginning at a point on the West boundary line of U. S. Highway No. 85, which is 250 feet North of the point of intersection of said West boundary line of said Highway No. 85, with the North boundary line of Fourth Street, in the Town of Lingle, Goshen County, Wyoming, according to the recorded plat thereof, which said point of beginning is also described as the Northeast corner of the City Park in the Town of Lingle, Wyoming;

Running thence northerly along said West boundary line of said Highway No. 85 a distance of 250 feet, more or less, to a point where the said West boundary line of said highway would intersect the North boundary line of Fifth Street, in the Town of Lingle, if said North boundary line of Fifth Street were extended easterly;

Running thence West along said North boundary line of Fifth Street, if extended as aforesaid, a distance of 520 feet, more or less, to the point where said North boundary line of Fifth Street, if extended, would intersect the north-south center line of the Southeast Quarter of said Section 18;

Running thence South along said north-south center line of the Southeast Quarter of said Section 18 a distance of 250 feet, more or less, to a point which is 250 feet North of the intersection of said line with the North boundary line of Fourth Street, in the Town of Lingle;

Running thence East a distance of 520 feet, more or less, along the line which is the North boundary line of the City Park, in the Town of Lingle, Wyoming, to the point of beginning.

In which the Co-op Addition to the Town of Lingle, Goshen County, Wyoming, is located as shown by the accompanying plat and Surveyor's Certificate; that said owner has caused the above described land to be surveyed and platted as Co-op Addition to the Town of Lingle, Goshen County, Wyoming, as shown by said plat and Surveyor's Certificate; that the streets and alleys indicated on said plat are hereby dedicated to the public for street and alley purposes.

The above and foregoing sub-division of the tract of land described above, in which the Co-op Addition to the Town of Lingle, Goshen County, Wyoming, is located, as shown by the accompanying plat and Surveyor's Certificate, as appears on this plat, is with the free consent, and in accordance with the desires of the undersigned owner and proprietor.

### SURVEYOR'S CERTIFICATE

I, Geo. W. Marks of Torrington, Wyoming do hereby certify that the CO-OP ADDITION TO TOWN OF LINGLE, GOSHEN COUNTY, WYOMING, was surveyed by me and is located in the NE 1/4 SE 1/4 of Section 18, T. 25 N.
