 A tract of land situated in Section Nine (9), Township Twenty-four (24), North, Range Sixty-one (61), West of the 6th P.M., Goshoe County, Wyoming, and more particularly described as follows:  
 Beginning at a point which is 60 feet West of the Northwest corner of Lot 5, Block 2, of the Curtis Addition to the Town of Torrington, according to the recorded plat thereof; proceeding thence West from said point of beginning a distance 140 feet to a point; proceeding thence South a distance of 300 feet to a point; proceeding thence East a distance of 140 feet to a point which is 60 feet West of the West boundary line of Lot 7 of Block 2 of the said Curtis Addition; proceeding thence North a distance of 300 feet to the point of beginning as appears on this plat; is with the free consent, and in accordance with the desires of the undersigned owners and proprietors; and the undersigned owner and proprietor hereby certifies that it is the sole owner of said lands, and has caused the same to be surveyed and platted as the English Lutheran Church Addition to the Town of Torrington, Goshoe County, Wyoming, as shown by said plat and surveyor's certificate.
