

**CERTIFICATE OF SURVEYOR**

I, Russell D. Schanel, of 4-2 Engineering and Land Surveying of Torrington, Wyoming, do hereby certify that this plat of Haight 2nd Addition was made from notes taken during an actual field survey on March 6, 1981, and that it correctly represents the lots, blocks, streets and alleys as marked on the ground by 1/2" iron re-bar with an aluminum cap marked R.L.S. 3511, and that the lands embraced in this subdivision are that part of the E 1/2 SE 1/4 of Section 10 and the W 1/2 SW 1/4 of Section 11, both in T24N, R61W, of the 6th PM, Goshen County, Wyoming, more particularly described as follows:

BEGINNING AT THE POINT OF INTERSECTION OF THE NORTHERLY BOUNDARY OF THE NORTH PLATTE DITCH R-O-W AND THE SOUTHERLY BOUNDARY OF EAST 20th AVENUE OF THE TOWN OF TORRINGTON EXTENDED, WHICH POINT IS MONUMENTED BY A 1/2" x 2" RE-BAR WITH ALUMINUM CAP MARKED P.E.L.S. 671; THENCE N89°49'01"E (N89°49'01"E BEING THE BEARING OF THE SOUTH BOUNDARY OF SAID EAST 20th AVENUE EXTENDED BASED ON A SOLAR OBSERVATION, WITH ALL OTHER BEARINGS IN THIS DESCRIPTION RELATIVE THERETO) ALONG THE SOUTH BOUNDARY OF SAID EAST 20th AVENUE EXTENDED, A DISTANCE OF 95.13 FEET TO A 1/2" x 2" RE-BAR WITH ALUMINUM CAP MARKED R.L.S. 3511; THENCE S00°32'01"W, ALONG A LINE PARALLEL WITH EAST 'M' STREET OF THE TOWN OF TORRINGTON, A DISTANCE OF 1020.0 FEET TO A 1/2" x 2" RE-BAR WITH ALUMINUM CAP MARKED R.L.S. 3511 ON THE NORTH BOUNDARY OF EAST 17th AVENUE OF THE TOWN OF TORRINGTON; THENCE S89°49'01"W, ALONG SAID NORTH BOUNDARY OF EAST 17th AVENUE, A DISTANCE OF 39.0 FEET TO A 1/2" x 2" RE-BAR WITH ALUMINUM CAP MARKED R.L.S. 3511; THENCE N00°32'01"E, ALONG A LINE PARALLEL WITH SAID EAST 'M' STREET, A DISTANCE OF 1020.0 FEET TO THE SOUTH BOUNDARY OF SAID EAST 20th AVENUE EXTENDED WHICH POINT IS MONUMENTED BY A 1/2" x 2" RE-BAR WITH ALUMINUM CAP MARKED R.L.S. 3511; THENCE N89°49'01"E, ALONG THE SOUTH BOUNDARY OF SAID EAST 20th AVENUE EXTENDED, A DISTANCE OF 244.67 FEET TO THE POINT OF BEGINNING AND CONTAINING 7.73 ACRES MORE OR LESS.

**DEDICATION**

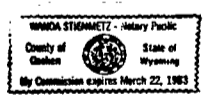
