SCHAMEL, OF 4,2 ENGINEERING & LAND SURVEYING OF TORRINGTON, WYOMING, HEREBY CERTIFY THAT THIS VACATION PLAT OF BLOCK 4 AND THE DEPICTED ALLEY WITHIN "HAUGHT 2ND ADDITION" TO THE TOWN OF TORRINGTON, WYOMING; AND THE REPLAT OF BLOCK 4 WITHIN "HAUGHT 2ND ADDITION" TO THE TOWN OF TORRINGTON, WYOMING, WAS MADE FROM NOTES TAKEN DURING AN ACTUAL FIELD SURVEY ON MARCH 6, 1981; THAT IT CORRECTLY REPRESENTS THE REPLAT OF BLOCK 4 AS MARKED ON THE GROUND BY 1/2" IRON RE-BAR WITH AN ALUMINUM CAP MARKED R.L.S. 3511; AND THAT THE LAND ENRAGED IN THIS REPLAT IS THAT PART OF THE SW 1/4 SW 1/4 OF SECTION 11, T24N, R4W, OF THE 6TH P.M., GOSHEN COUNTY, WYOMING, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 1/2" IRON RE-BAR W/AL. CAP R.L.S. 3511 MARKING THE POINT OF INTERSECTION OF THE NORTH BOUNDARY OF EAST 17TH AVENUE AND THE EAST BOUNDARY OF EAST L' STREET IN THE "HAUGHT 2ND ADDITION" IN THE TOWN OF TORRINGTON, WYOMING; THENCE N68°32'0"E, ALONG THE EAST BOUNDARY OF SAID EAST L' STREET, A DISTANCE OF 300 FEET TO A 1/2" IRON RE-BAR W/AL. CAP R.L.S. 3511 SET ON THE SOUTH BOUNDARY OF EAST 18TH AVENUE; (N68°32'0"E BEING THE BEARING OF THE EAST BOUNDARY OF SAID EAST L' STREET BASED ON A SOLAR OBSERVATION MADE ON THE WEST LINE OF THE SW 1/4, SECTION 8, T24N, R4W, WITH ALL OTHER BEARINGS HEREIN RELATIVE THERETO) THENCE N89°40'0"E, ALONG THE SOUTH BOUNDARY OF EAST 18TH AVENUE, A DISTANCE OF 130 FEET TO A 1/2" IRON RE-BAR W/AL.
