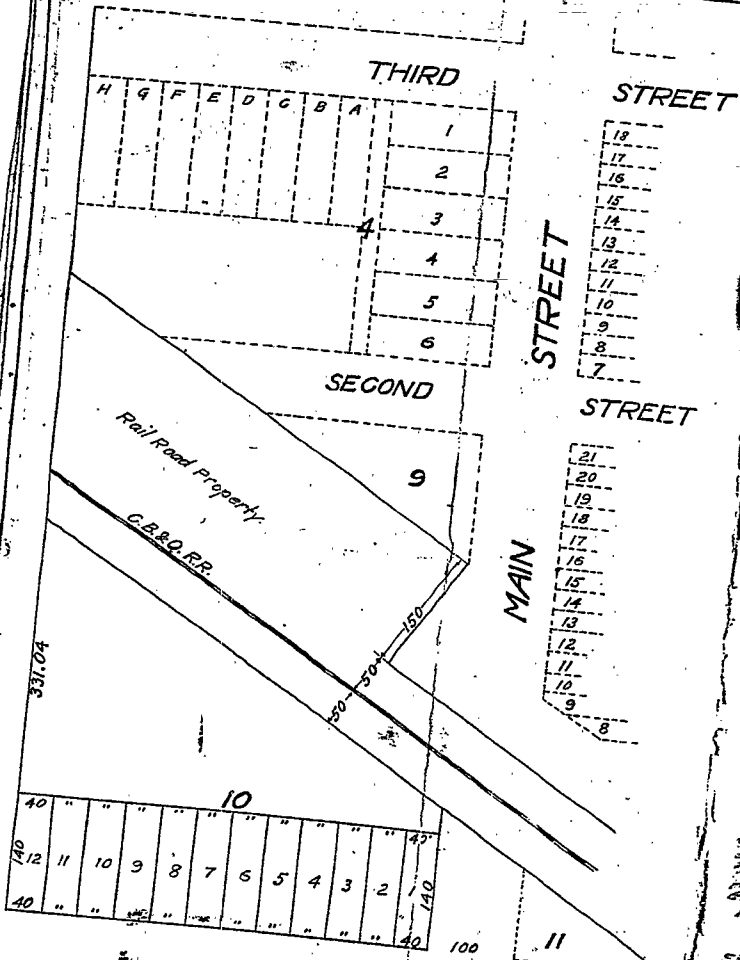


LEITER'S SUBDIVISION
