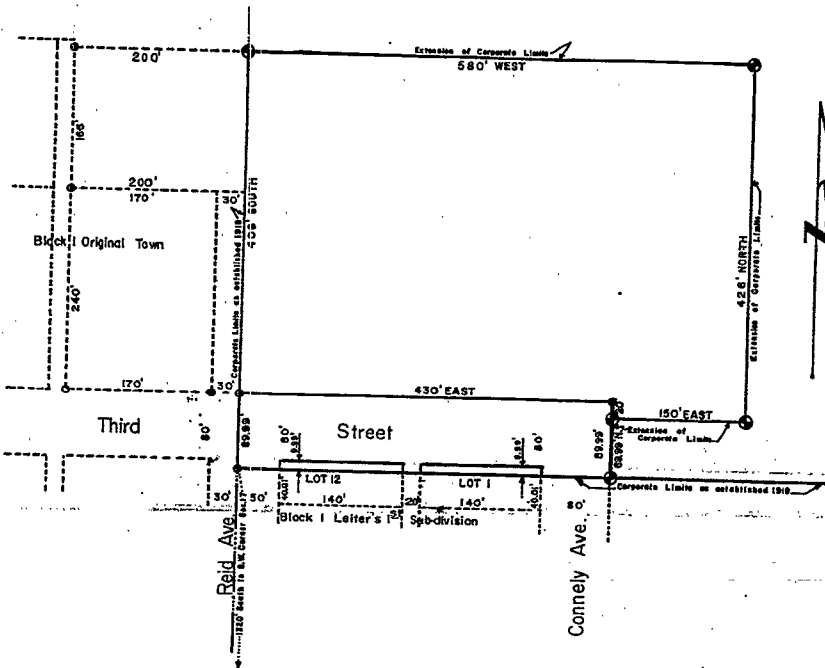


MAP SHOWING EXTENSION OF CORPORATE LIMITS OF TOWN OF LINGLE, GOSHEN COUNTY, WYOMING.
