SURVEYOR'S CERTIFICATE

I, J. G. Marzel of Torrington, Wyoming, do hereby certify that this plat of MisKimin's Addition to LaGrange, Wyoming, was made from notes taken during an actual survey made under my direction by C. L. Huntley for whose work I stand directly responsible. The survey was made during the month of February, 1928 upon the following described land,即 the portion of the North Half (N1/2) of Section Thirteen (13), Township 12 North, Range 6 West of the 6th P.M., Goschen County, Wyoming, as is shown on the annexed plat, which is a correct delineation of said survey drawn to a scale of 200 feet to an inch and more particularly described as follows: Beginning at a point 13 feet east of the northwest corner of Griffin's Addition to LaGrange, Wyoming, and running thence south 41° 54' feet to the southwest corner of the above described Section 11, which point is on the southwest corner of Griffin's Addition to LaGrange, Wyoming, and running thence south 41° 54' feet on a line parallel to the west line of said Section 11, thence east on a line at right angles thereto to the west line of the right of way of the Pacific Railway Company, thence 4° northwesterly direction along the west line of said right of way to the center line of N Street, Griffin's Addition to LaGrange, Wyoming, and thence 90° clockwise to the center line of said N Street to the point of beginning. The avenues are laid out parallel to the east line of said Section 11 and M Street is laid out at right angles thereto, 2" x 2" x 1" fir-tree timber, centered in each lot, are driven flush with the ground at the front corners of each lot. The widths of the streets, avenues and alleys and the dimensions of the lots are indicated on the annexed plat in feet and decimals and each lot and block bears its own number.
