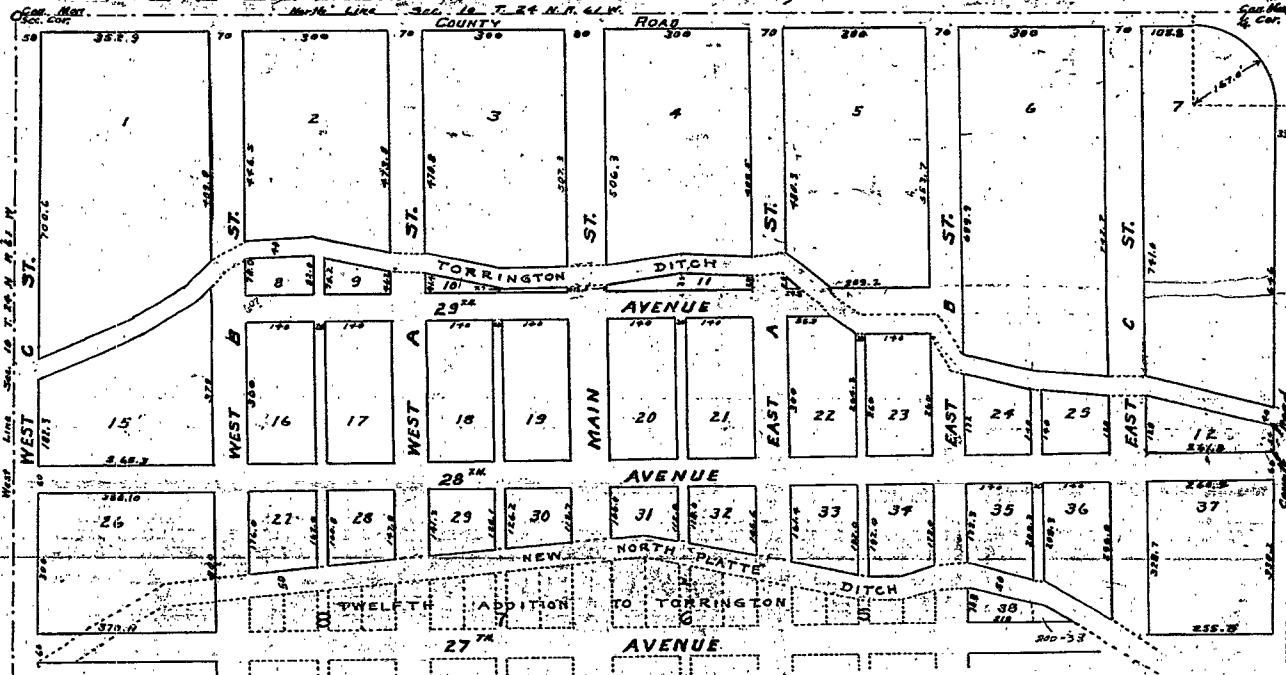


NORTH TORRINGTON SUBDIVISION GOSHEN COUNTY, WYOMING

SURVEYOR'S CERTIFICATE

I, Geo. W. Marks, of Torrington, Wyoming, do hereby certify that the NORTH TORRINGTON SUBDIVISION, GOSHEN COUNTY, WYOMING, was surveyed by me; that said Subdivision is located in a part of the North Half of the Northwest Quarter (N $\frac{1}{2}$ NW $\frac{1}{4}$) of Section 10, in Township 24 North, Range 61, West of the 6th P.M., as shown by the annexed plat, which is a correct delineation of said survey, drawn to a scale of 200 feet to the inch.
