

**SURVEYOR'S CERTIFICATE**

I, Russell D. Schamel, of 4412 Engineering and Land Surveying in Torrington, Wyoming, hereby certify that this Replat of the northerly portion of Rock Ridge Drive in the "Rock Ridge Addition" in Goshen County, Wyoming, was made from notes taken during an actual survey made in September, 1983, and that it correctly represents the originally surveyed and platted portion of Rock Ridge Drive and the replatted portion of Rock Ridge Drive.

I also certify that this replat does not alter any existing lot lines between lots within the legally recorded "Rock Ridge Addition" and that the replatted location of Rock Ridge Drive meets or exceeds the minimum dimensional requirements for Roads and Cut-de-sacs within subdivisions in Goshen County, Wyoming. The lots in the Rock Ridge Addition enlarged and created by this replat of Rock Ridge Drive are Lots 4, 5, 6, 7, 8, 9, 10, and 13, with the square footage of enlargement for each indicated below. The purpose and intent of this replat is to create more desirable and buildable lots along Rock Ridge Drive on top of the narrow projecting ridge.

No certification is made to the accuracy of the Original "Rock Ridge Addition" Plat; however, original subdivision corner monuments were found as shown on this replat and 1/2" x 2" re-bar with aluminum cap P.E.L.S. #3511 are driven flush with ground at the new corners created by this replat in positions as shown relative to the original corner monuments (i.e. 1/2" x 1" re-bar with aluminum cap P.E.L.S. #477) as found originally set and driven flush with the ground.

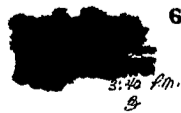
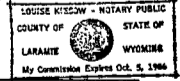
