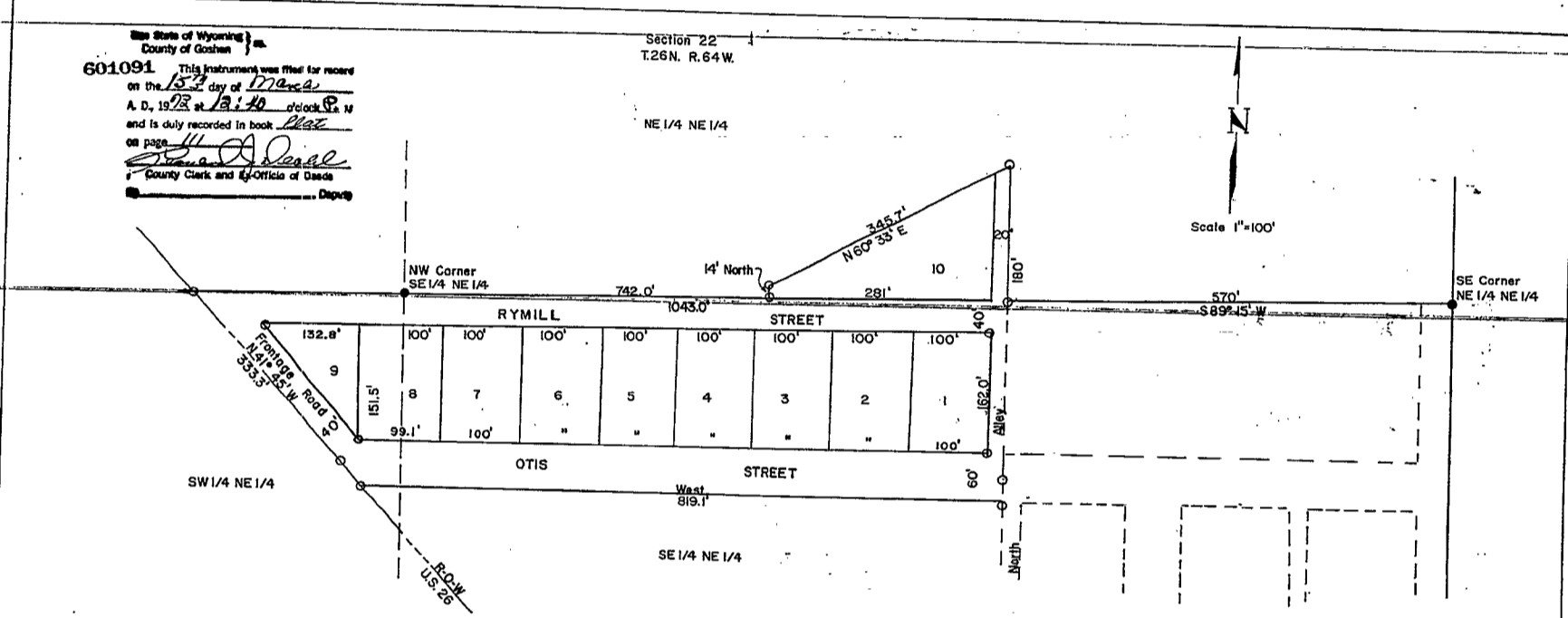

CERTIFICATE OF SURVEYOR

I, Donald R. Horton of Torrington, Wyoming, hereby certify that this plat of Rymill Addition was made from notes taken during an actual survey made by me in February, 1973; that it correctly represents the Blocks, Lots, Streets and Alleys as marked on the ground by 5/8" x 2" re-bar at block corners, control corners and wood stakes at other lot corners and that the land embraced in this sub-division is part of the NE 1/4 NE 1/4, Section 22, T.26N., R.64W., 6th P.M., Goshen County, Wyoming, containing 6.14 acres more or less and more particularly described as follows: Beginning at a point that is S 89° 15' W, a distance of 570 feet from the SE Corner of said NE 1/4 NE 1/4, Section 22, T.26N., R.64W.; thence South, a distance of 262.0 feet; thence West, a distance of 819.1 feet; thence along the Northerly boundary of U.S. Highway 26, N 41° 15' W, a distance of 333.3 feet; thence N 89° 15' E, a distance of 742.0 feet; thence North, a distance of 14.0 feet; thence N 60° 33' E, a distance of 345.7 feet; thence South, a distance of 180.0 feet to the point of beginning.
