 SUBDIVISION, GOSHEN COUNTY, WYOMING, SITUATED ON A PART OF THE  
 SE 1/4 OF THE SW 1/4 OF SEC. 15, IN TOWNSHIP 24 NORTH, RANGE 61 WEST  
 THE 6TH PM, AS SHOWN BY THE ANNEXED PLAT, WHICH IS A CORRECT  
 DELINEATION OF SAID SURVEY, DRAWN TO A SCALE OF 200 FT. TO THE

 BEING FROM 1 TO 19, BOTH INCLUSIVE.
