The streets shown on this plat are extensions of those of the same name in the city of Torrington. The first and second streets shown on this plat are laid out parallel with Sycamore street in the city of Torrington. 100 penny stakes are driven well into the ground at the front corners of each lot and lots 1 to 6 are marked with iron spikes. The width of streets, avenues and alleys and dimensions of lots are indicated in feet and decimals by red figures on the plat. Each lot and street bears its number and name.
