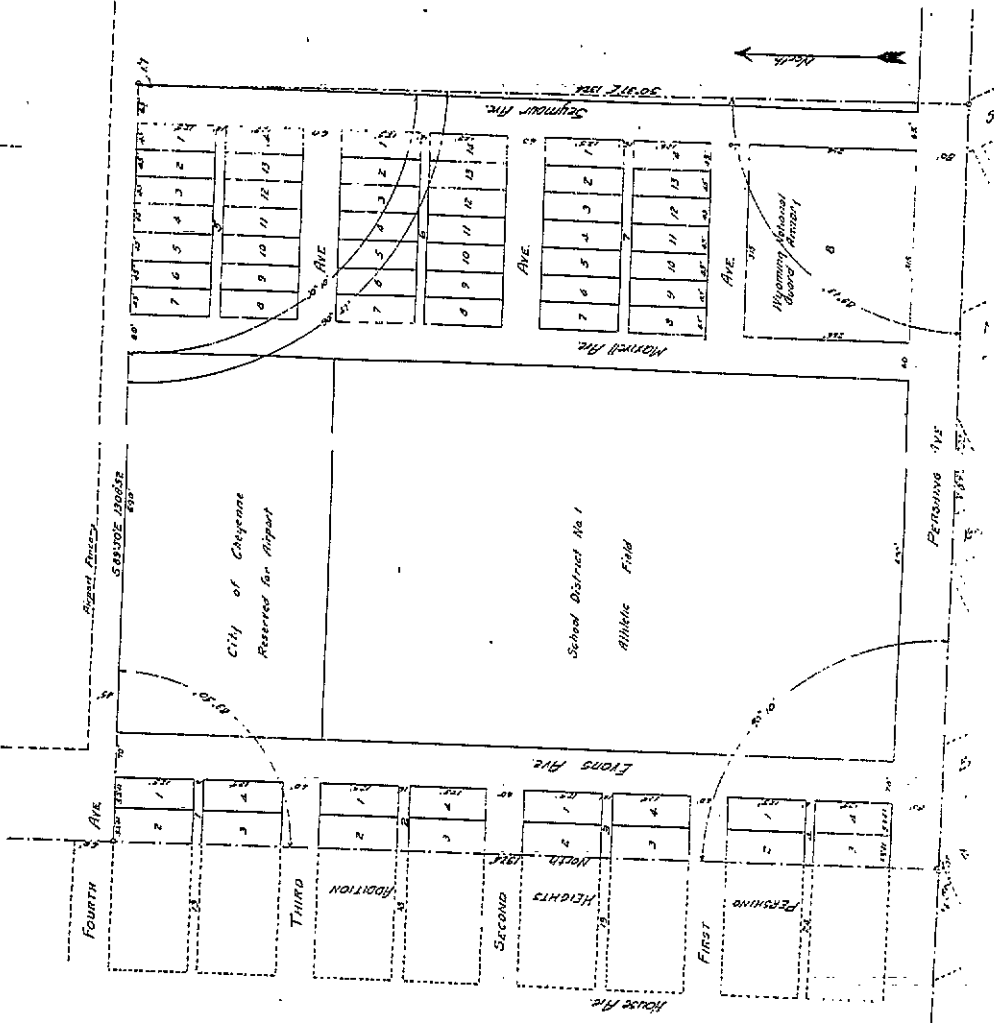
Description
This Airport Addition to the City of Cheyenne, Laramie County, State of Wyoming, embraces all that portion of Section 30, T. 14 N., R. 66 W., and being more particularly described as follows:
Beginning at the 1/4 corner between Sections 30 and 31, T. 14 N., a distance of 1324 feet to a brass cap set in iron pipe; thence S 89° 50' E 1308.52 feet to a brass cap set in iron pipe; thence S 0° 37' E 1354 feet to a brass cap set in iron pipe; thence thence 1324.22 feet to the point of beginning.
