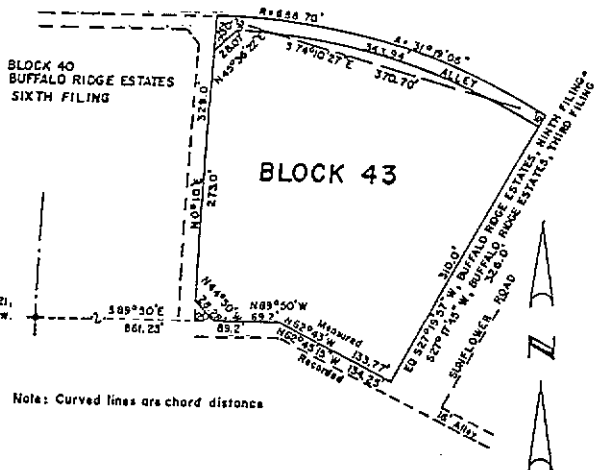


SURVEYOR'S CERTIFICATE

I, Richard E. Myrick, of Cheyenne, Wyoming, hereby certify that this plat of BUFFALO RIDGE ESTATES, NINTH FILING, an addition to the City of Cheyenne, Laramie County, Wyoming, was made from notes taken during an actual survey made by me during August, 1966, and that it correctly represents said survey as marked on the ground with iron pipe set at block corners, PC's and PT's, and I further certify that the land embraced in this subdivision is part of the NE 1/4 NW 1/4 SE 1/4, SW 1/4 NE 1/4, Section 21, T.14N., R.66W., 6th P.M., Laramie County, Wyoming, containing 2.23 acres, more or less, and being more particularly described as follows: Beginning at a point on the east-west centerline of said Section 21, which point bears S89°50'E a distance of 861.23 feet from the center of said Section 21 and thence proceeding N0°10'E a distance of 329.0 feet to a point, which point is the P.C. of a curve to the right, thence along said curve to the right the radius of which is 646.70 feet and the chord bears S7°10'27"E a distance of 370.70 feet to a point, thence S27°19'57"W a distance of 328.0 feet to a point, thence N62°43'W a distance of 133.77 feet to a point, thence N89°50'W a distance of 89.2 feet to the point of beginning hereinbefore described. I further certify that the Bearing Equation shown on the east line of Block 43, BUFFALO RIDGE ESTATES, NINTH FILING represents a common line between said Block 43 and Blocks 22, 25 and 26, BUFFALO RIDGE ESTATES, THIRD FILING.
