



**ENGINEER'S CERTIFICATE**

 I, J. H. Baldwin, of Cheyenne, Wyoming, hereby certify that this plat of DREW SUB-DIVISION was made from notes taken during a survey made under my direction in May, 1958, that it shows accurately the lots, blocks, streets and alleys as marked on the ground, by an old plat set of all black corners and iron spikes set at all other lot corners and that the land embraced in this subdivision is all of the south 290 feet of Tract 92, Allison Tracts, Third Filing, Laramie County, Wyoming, containing 1.58 acres, more or less, and being more particularly described as follows:
