I hereby certify that on or about the month of August 1890 I established the S.E. and S.W. corners of Lot 221 of Sec. 36 T. 14 N. R. 17 W. according to the field notes in the Survey Bureau of files by running a line from the N.E. corner of said Sec. 36 to the E. quarter corner, being 1000.00 feet. The proper proportion for Lot 221 being 1000.00 feet, and running from the corner of Sec. 36 to the corner on S. line of military reservation, being 1278.00 feet. The exact location of Holgren's addition to Cheyenne being 1278.00 feet from the point of which being wholly indefinite as to the exact boundary and also uncertain between the S.E. corner of Lot 221 and the S.W. corner of the original town of Cheyenne as located by the Amended Survey will be the true boundary line of said corner, it is further the true between Lot 221 and Lot 222 (the lot 222 being depicted in the foregoing plat) it being here delineated as a part of said lot 221 and will separate the lot in blocks 7 and 8 as shown by the plat which is a correct delineation of said survey and is a line of 100 feet in width, on which we marked all distances north of block and south of block in the original survey although somewhat irregular as to their width. 3 lot blocks of the plat and the plat to determine the width of the fractional lot as marked on the ground and measure the distance between the blocks as not changed and the order of the numbers of the lot which we have marked by the line of negotiation, thereby dropping the numbers of the lot boundary of the neighborhood has also delineating the block lot of the blocks which were delineated as part of lot 221.
