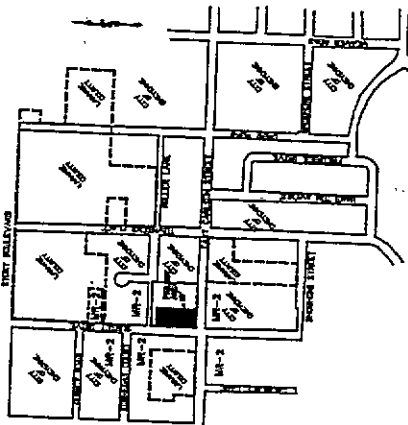
LEGAL DESCRIPTION
