



### ENGINEER'S CERTIFICATE

I, T.H. Baldwin, of Cheyenne, Wyoming, hereby certify that this plat of MOUNTVIEW PARK, SEVENTH FILING was made from notes taken during an actual survey made under my direction in April, 1957; that it accurately represents the block, streets and alleys as marked on the ground by iron pipe set at the block corners; and that the land embraced in this subdivision containing 5.17 acres, more or less, is all that part of the NE 1/4 Section 33, T. 14 N., R. 66 W., 6th P.M., Laramie County, Wyoming, described as follows: Beginning at the north-east corner of MOUNTVIEW PARK, FIFTH FILING, City of Cheyenne, Laramie County, Wyoming, which point of beginning is 40 feet south and 1214.8 feet west of the north-east corner of said Section 33; thence S 0° 02' W, along the east boundary of said Mountview Park, Fifth Filing, which boundary is also the east line of Forest Drive, a distance of 486 feet to a point on the north line of Olive Drive, extended; thence S 89° 58' E, along the north line of said Olive Drive, extended, a distance of 465.65 feet to a point; thence N 0° 02' E, parallel to the east line of said Mountview Park, Fifth Filing, a distance of 486 feet to a point on the south R/W line of Pershing Boulevard; thence N 89° 58' W along the south R/W line of Pershing Boulevard, a distance of 465.65 feet to the point of beginning.
