



SURVEYOR'S CERTIFICATE

The State of Wyoming
County of Laramie

I, Robert C. Condit of Laramie County, Wyoming, hereby certify that this plat of Mylar Park, an addition to the City of Cheyenne, Wyoming, was made from a survey taken during an actual survey made by me in October and November, 1970, that it accurately represents the above named addition as marked on the ground by iron pins set at all corners, that the area comprises a portion of the NW 1/4 SE 1/4, Section 19, T 14 N, R 66 W, 6th PM, Laramie County, Wyoming, containing 23.51 acres, more or less, and being more particularly described as follows: Beginning at a point 2 07' 01" E a distance of 190.00 feet from the corner 1/4 corner of Section 19, said point being the SW corner of Indian Hills Subdivision 8th Filings; Thence: S 93°-59' E a distance of 300.02 feet to a point; Thence: S 0°-02' 7" E a distance of 192.00 feet to a point; Thence: S 89°-59' E a distance of 89.89 feet to a point on the west boundary of Indian Hills Subdivision 4th Filings; Thence: S 0°-02' 7" E along the west boundary a distance of 616.05 feet to a point; Thence: Due west a distance of 310.98 feet to a point; Thence: Due south a distance of 199.59' feet to a point; Thence: Due west a distance of 354.98 feet to a point; Thence: N 49°-28' W a distance of 230.75 feet to a point; Thence: Due west a distance of 450.98 feet to a point on the east boundary line of Indian Hills Subdivision 3rd Filings; Thence: N 0°-01' W along the east boundary a distance of 838.45 feet to the point of beginning.

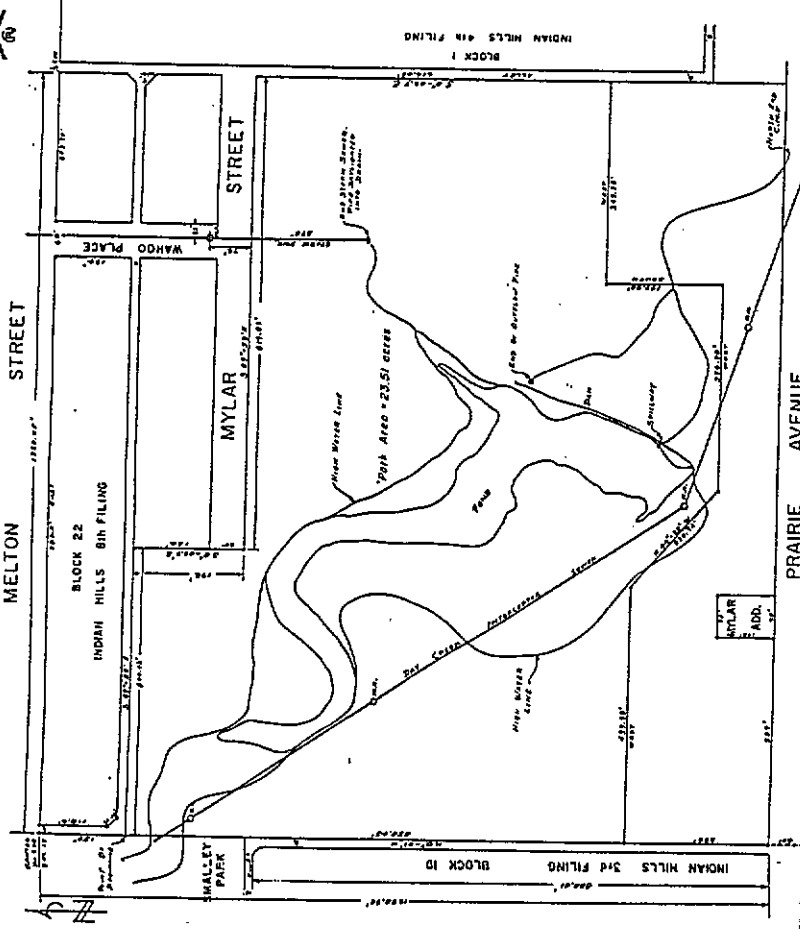
