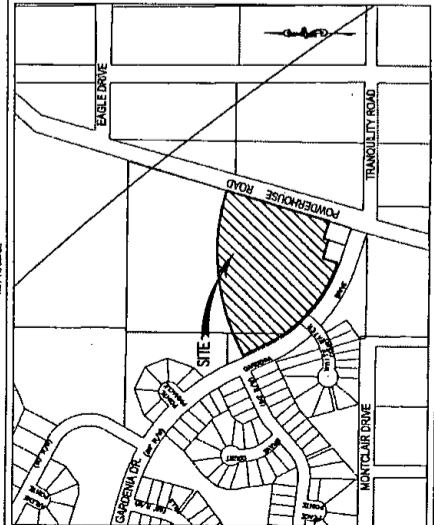

LEGAL DESCRIPTION

AN ADMINISTRATIVE REPLAT OF BLOCK 1, LOTS 4 THRU 32 OF "POINTE PLAZA" BEING SITUATED IN THE SOUTHWEST ONE-QUARTER OF SECTION 17, AND THE SOUTHEAST ONE-QUARTER OF SECTION 18, TOWNSHIP 14 NORTH, RANGE 66 WEST OF THE SIXTH PRINCIPLE MERIDIAN, CITY OF CHEYENNE, LARAMIE COUNTY, WYOMING AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF SAID BLOCK 1, LOT 32 OF "POINTE PLAZA", SAID POINT ALSO BEING THE INTERSECTION OF THE WEST AND SOUTH RIGHT OF WAY LINES OF POWDERHOUSE ROAD AND SPIRIT LANE, THENCE ALONG THE POWDERHOUSE ROAD RIGHT OF WAY S16°42'00"W A DISTANCE OF 528.47 FEET, THENCE LEAVING SAID POWDERHOUSE ROAD RIGHT OF WAY THE FOLLOWING COURSES AND DISTANCES:
