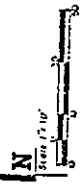


LEGAL DESCRIPTION

A tract of land situated within the SE 1/4 SE 1/4 of Section 26, T. 12 N., R. 67 E., 4th P.M., Laramie County, Wyoming, being more particularly described as follows:

Beginning at a point which is 100 feet South of the East and West center line of Section 26 and West 40 feet from the East line of the said Section 26, thence North on an azimuth of 0°00'00" along the Laramie Road Right-of-Way 40 feet to the Southeast corner of Block 2, Davis Addition, thence on an azimuth of 208°21'52" along the South boundary of Block 2, Davis Addition for a distance of 208.21 feet to the East line boundary of Block 1, Westgate Addition, thence on an azimuth of 101°00'00" along the East line boundary of Block 1, Westgate Addition for a distance of 208.21 feet to a point on the South boundary of Block 1, Westgate Addition on an azimuth of 89°58'52" along said South boundary of Block 1, Westgate Addition for a distance of 208.21 feet to the point of beginning.

Said parcel of land contains 4353.26 square feet or 1.0 acre more or less.
