

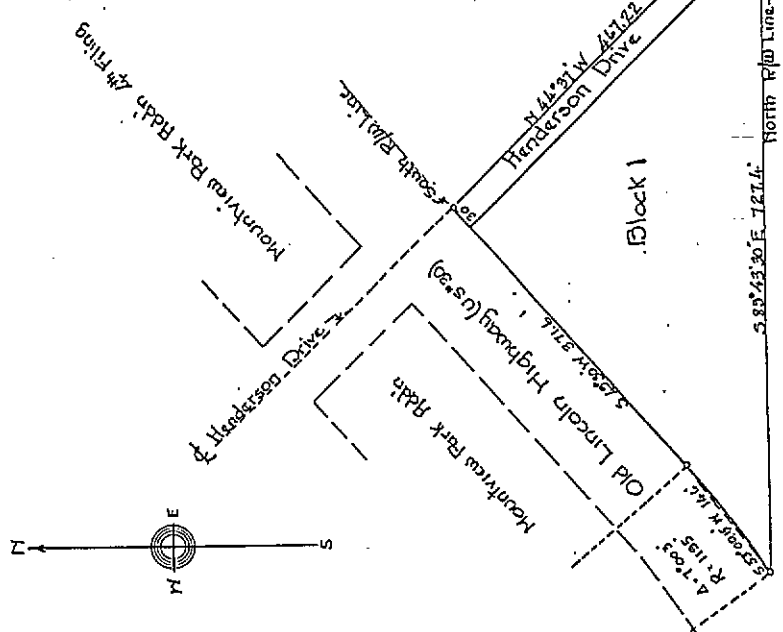
ENGINEER'S CERTIFICATE

The State of Wyoming, County of Laramie, Wyoming, hereby certifies that this map of Triangle Addition to the City of Cheyenne, Laramie County, Wyoming was made from notes taken during an actual survey made under my direction in June 1952 and that it accurately represents the subdivision as marked on the ground by iron pins set at all corners and I further certify that the land embraced in this subdivision is a part of SW 1/4 of Section 33, T14N, R11E, and is more particularly described as follows: Beginning at the intersection of the north & W line of the Lincoln 4 Lane Divided Highway and the center line of Henderson Drive, in Mountain View Park, Cheyenne, Wyoming, extended southeasterly said point of beginning being 1615.15 feet west and 151 feet north of the E 1/4 corner of said Section 33; thence N 74° 37' W, along the center line of said Henderson Drive extended, a distance of 447.22 feet to a point on the south & W line of the Old Lincoln Highway; thence S 49° 30' W, along said south & W line, a distance of 311.6 feet to a point of curve; thence along said & W line on a curve to the right, whose radius is 1195 feet, through a central angle of 7° 03', whose long chord bears S 53° 05' W and whose length is 146 feet to an intersection with the north & W line of said 4 Lane Divided Highway; thence S 87° 43' 30' E, along the north & W line of said Divided Highway, a distance of 727.4 feet to the point of beginning; containing 2.76 acres more or less.
