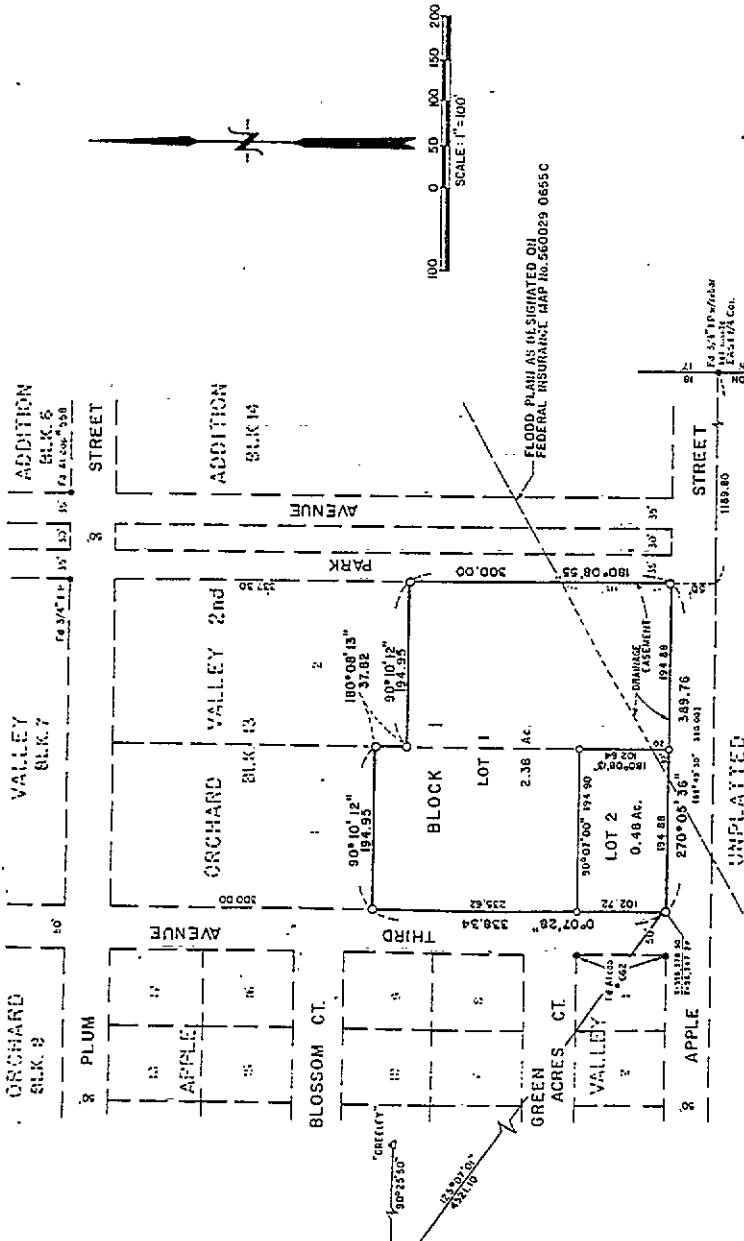

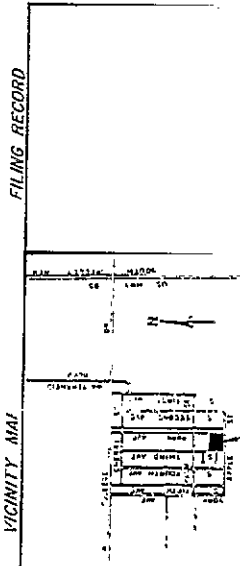
1. Bets of Arithuth City of Cheyenne below, referenced from stations "ORCHARD" and "GREENEY".
