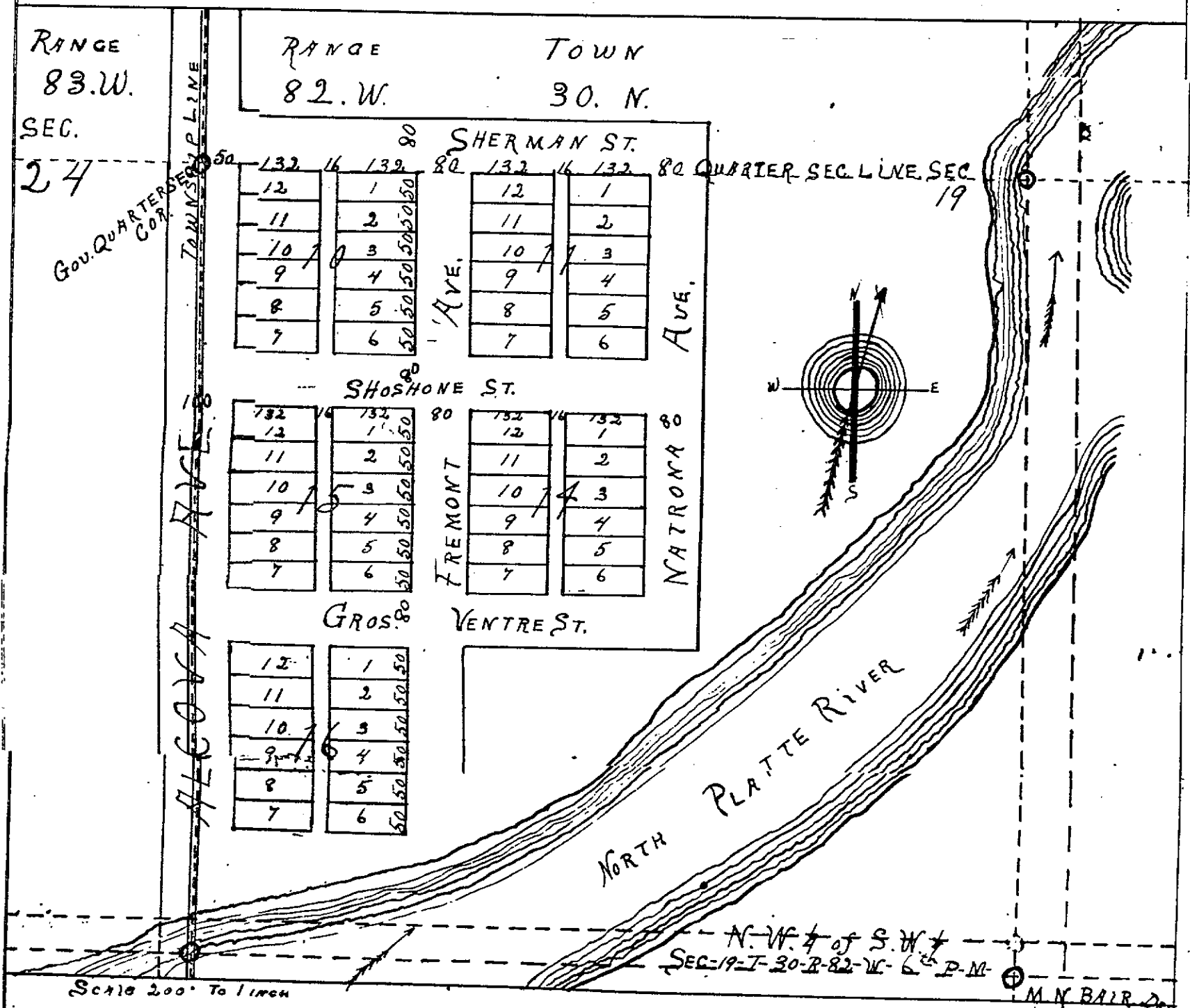
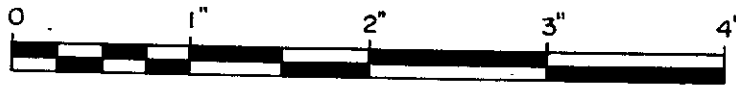

COVENANT
