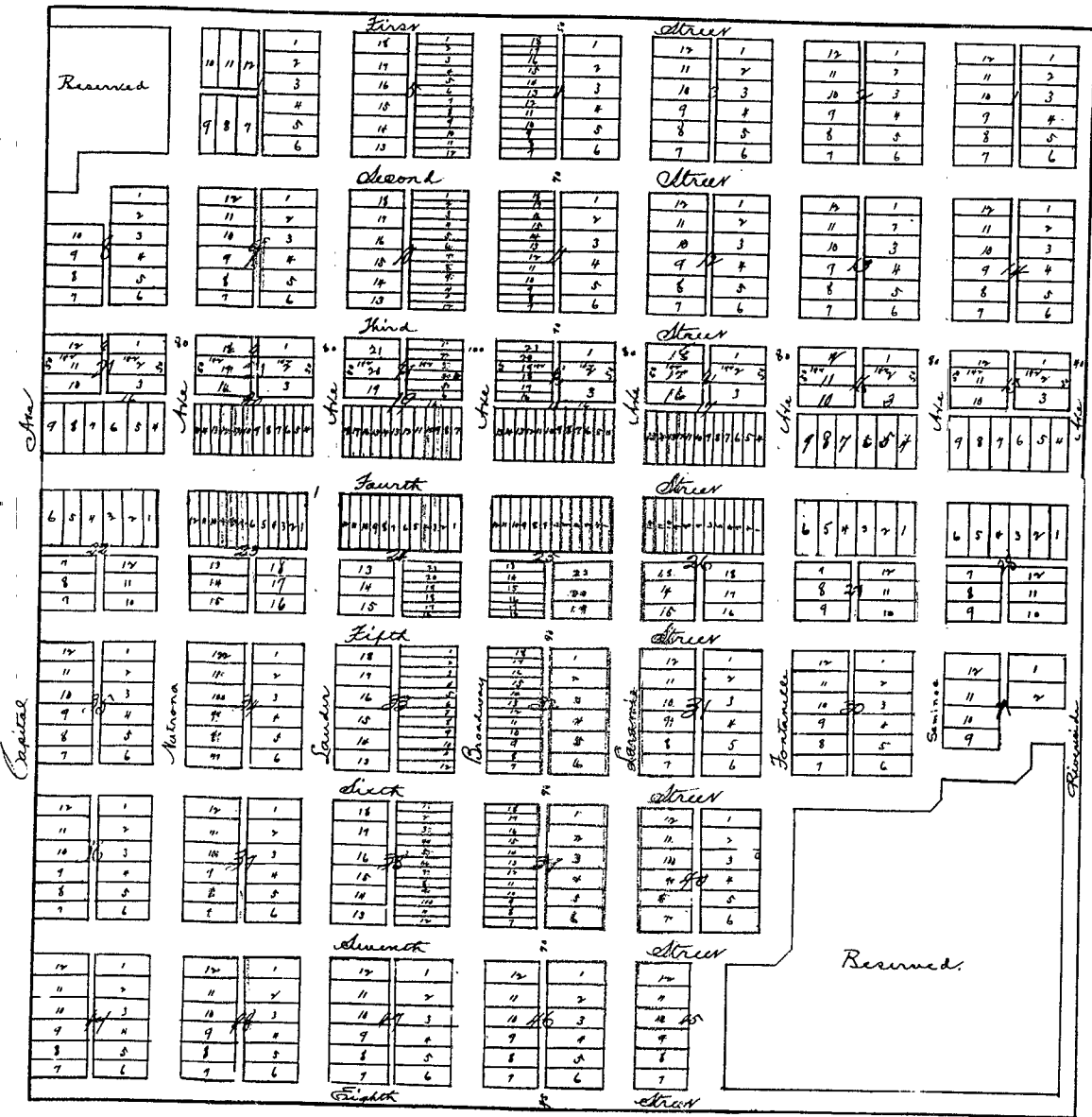


Plan of

Carbon County

I hereby certify that in the month of March 1888
I surveyed the Town of Bessemer, located on the north
east quarter of section 4 Township 32 N Range 81
West, Carbon County, Wyoming, as is more definitely
shown by the foregoing plat which is a correct delineation
of said survey drawn to a scale drawn to a scale of
two feet to the inch. The north line of said section 4
is taken as a base line for the survey and all streets
are laid parallel with and at right angles to said
base line. Five stakes of inches long are driven at the
four corners of each lot and each lot is marked with
its own number the width of all streets and alleys
and the dimensions of all lots are marked in feet
and decimals in red figures on the plat.
