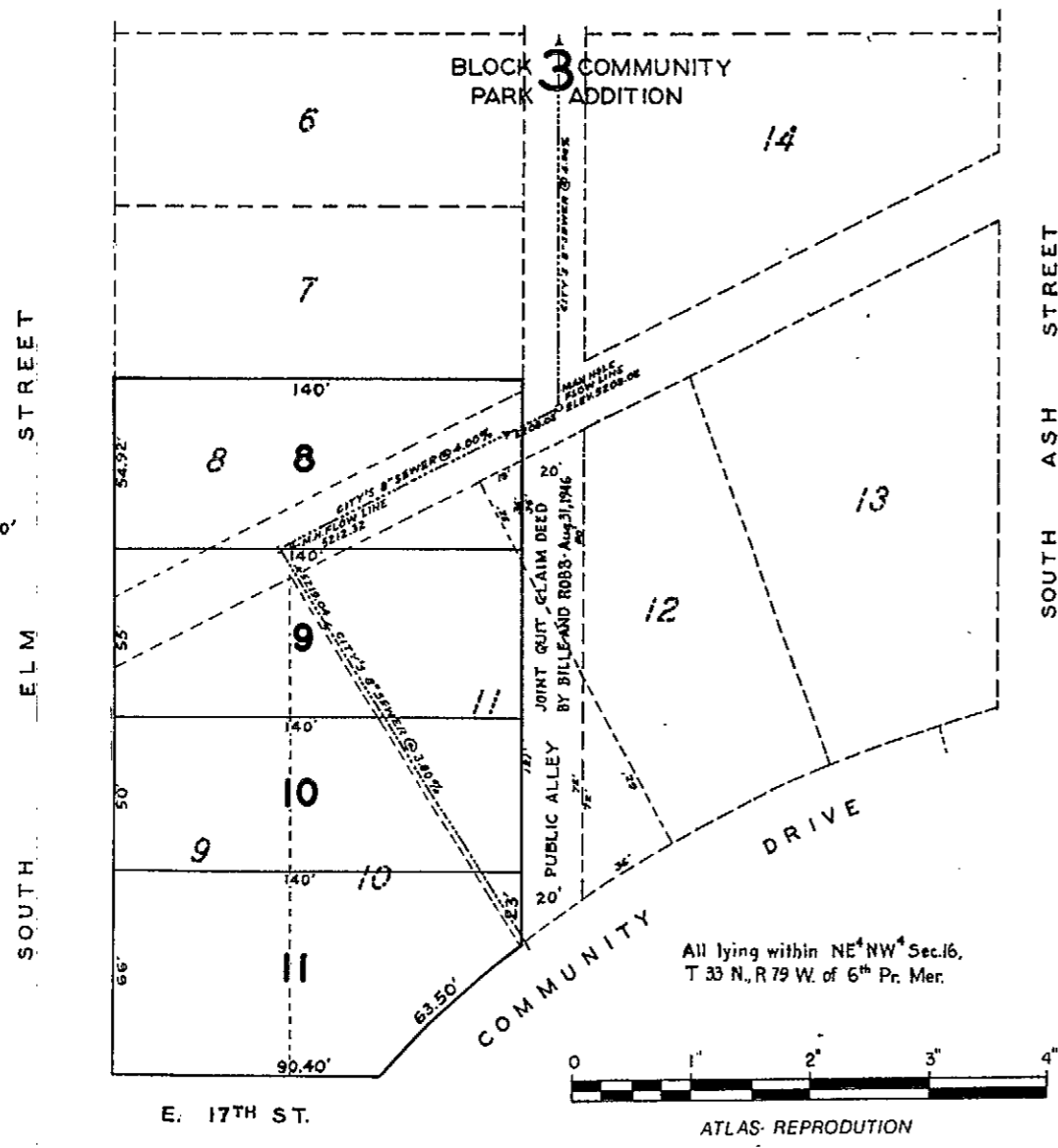

 The undersigned, GEORGE E. BILLE and FERNE I. BILLE, husband and wife, do hereby certify that the above and foregoing RESUBDIVISION OF LOTS 8, 9, 10 AND THE WEST PORTION OF LOT 11 AND THE NORTHWEST CORNER OF LOT 12, BLOCK 3, COMMUNITY PARK ADDITION TO THE CITY OF CASPER, NATRONA COUNTY, WYOMING, as said Lots and Blocks are laid down and described on that certain plat of Blocks numbered 1 to 37 inclusive filed for record in the office of the County Clerk and Ex-Office Register of Deeds of Natrona County, Wyoming, on the 22nd day of July, 1922, and there recorded in Book 33 of Deeds at page 616, as appears on this plat as Lots with progressive numbers 8 to 11, both inclusive, this resubdivision being known as "BILLE'S RESUBDIVISION OF LOTS 8, 9, 10 AND PARTS OF 11 AND 12 IN BLOCK 3, COMMUNITY PARK ADDITION TO THE CITY OF CASPER, NATRONA COUNTY, WYOMING," is with the free consent and in accordance with the desires of the above named and undersigned owners and proprietors thereof.
 And it is hereby provided that this plat is made, executed, acknowledged and filed for record by said undersigned owners and proprietors for the purpose and with the intention that definite, certain and clear descriptions of the several lots on this plat laid down and described may be available.
 Provided always that this Resubdivision is made subject to the right of the City of Casper, Natrona County, Wyoming, to maintain a public alley or thoroughfare over and across that portion of said real estate particularly described in that certain Quit Claim Deed dated August 31, 1946, from the undersigned and H. M. Robb and Fannie M. Robb, husband and wife, grantors, to said City of Casper, grantee, and also subject to the right of said City of Casper to operate and maintain the sewer line where it now crosses the above described real estate.
