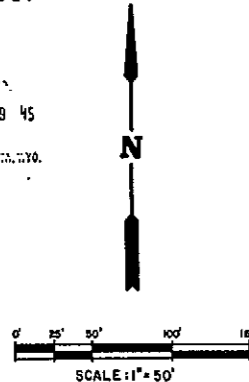

CERTIFICATE OF DEDICATION

Blaze Oil Company hereby certifies that it is the owner and proprietor of the foregoing subdivision, located in and being a part of the Southeast quarter, Southwest quarter of Section 1, Township 33 North, Range 79 West, 6th Principal Meridian, Natrona County, Wyoming, being more particularly described as follows:

Commencing at a point on the south line of said Section 1 which is South 89°57'54" East a distance of 1501.60 feet from the southwest corner and North 89°57'54" West a distance of 1121.60 feet from the south quarter corner thereof, thence North 0°00'33" West a distance of 269.98 feet, thence North 89°12'55" East a distance of 263.12 feet to the true point of beginning said point being the southwest corner of the parcel hereon described, thence North 0°02'03" West a distance of 227.94 feet along the westerly boundary of said parcel and the easterly boundary of the Mc G Addition to a point on the southerly right of way line of Legion Lane, thence North 89°18'20" East a distance of 263.08 feet along the southerly right of way line of Legion Lane and the northerly boundary of said parcel to a point on the westerly right of way line of Curtis Street (Wyoming Blvd.), thence South 0°02'37" East a distance of 227.76 feet along the westerly right of way line of Curtis Street (Wyoming Blvd.) and easterly boundary of said parcel, thence South 89°12'55" West a distance of 263.12 feet along the southerly boundary of said parcel to the point of beginning. 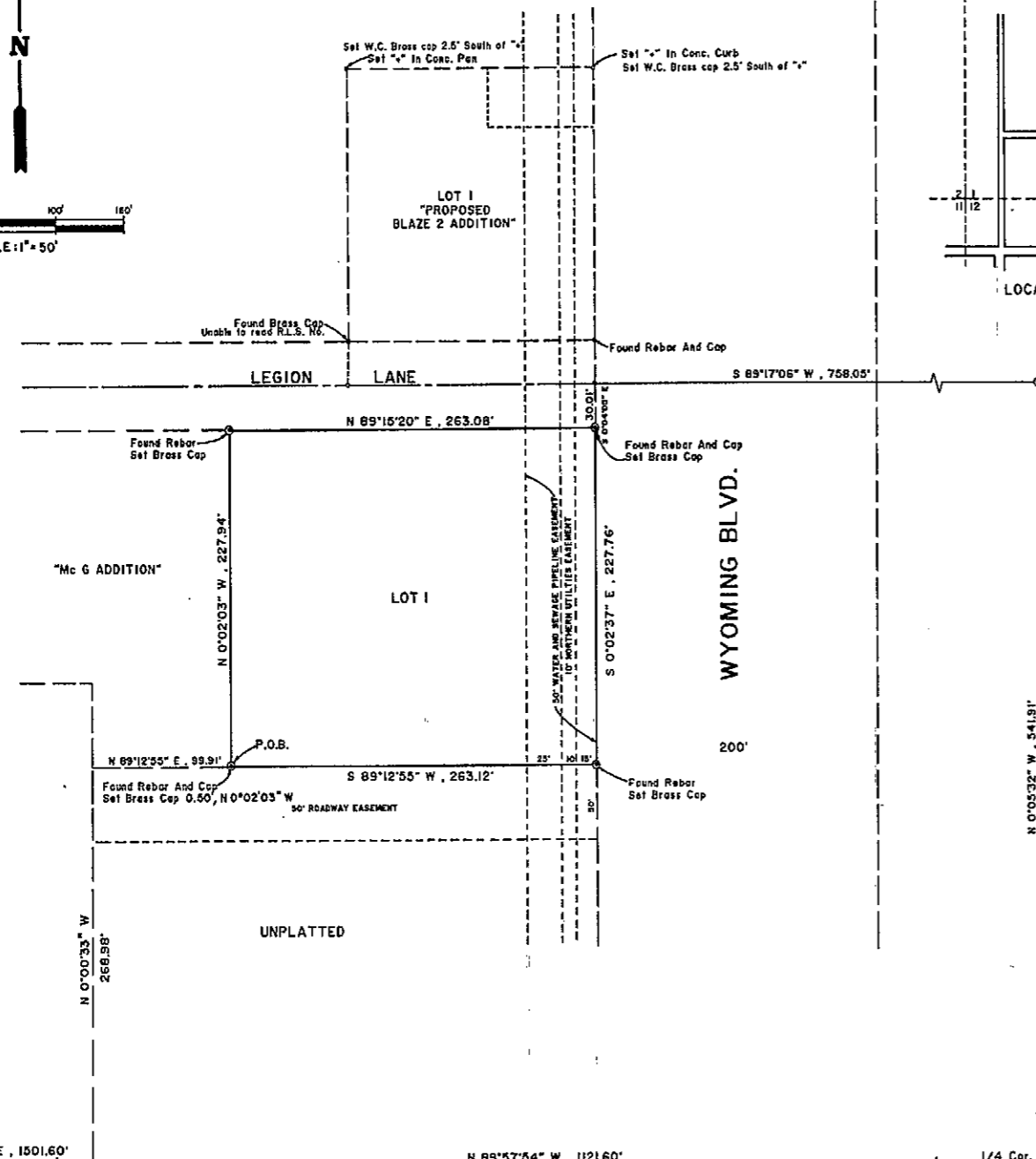
