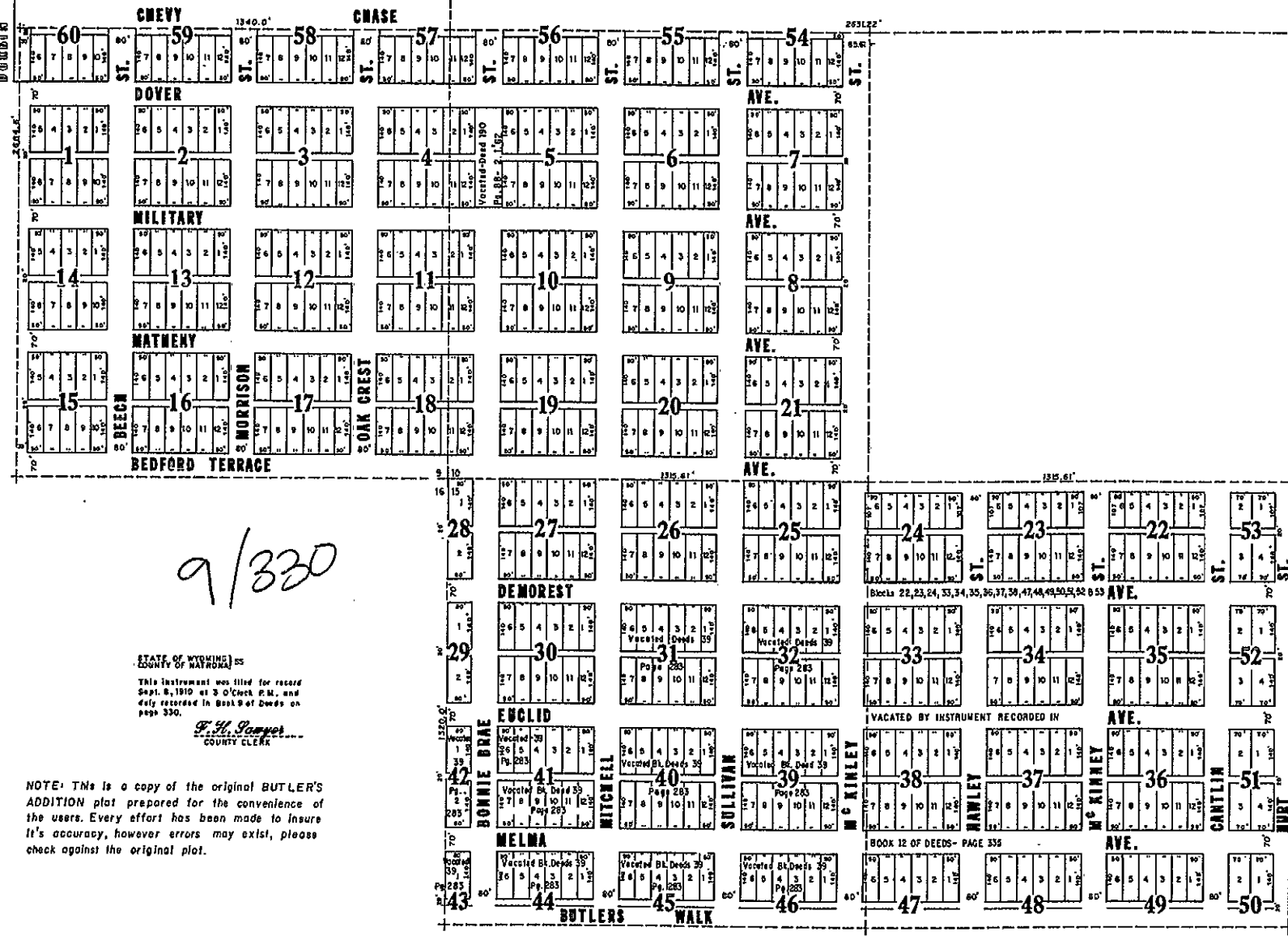
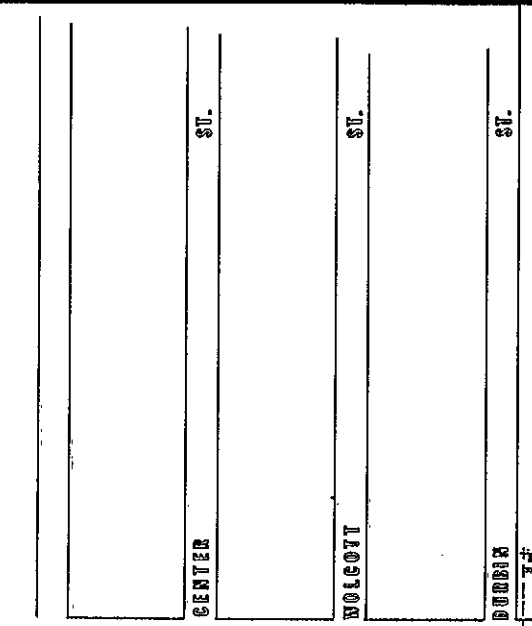


# BUTLER'S ADDITION TO THE TOWN OF CASPER, WYOMING

### Plat and Dedication

STATE OF WYOMING ] SS

W.F. Dunn, being first duly sworn on his oath deposes and says: That he is a duly licensed surveyor, that at the request of the Mountain Realty and Title Corporation, the owners of the SE 1/4 of the SE 1/4 Sec. 9; The SW 1/4 of the SW 1/4 Sec. 10; The N 1/2 of the NW 1/4 Sec. 15, T.33 N., R.79 W., in Natrona County, Wyoming;  
He sub-divided said land into Blocks, Lots, Streets and Alleys, which said sub-division is to be known as "BUTLER'S ADDITION" to the Town of Casper, County of Natrona, Wyoming, and is more definitely shown by the foregoing plat, which is a correct delineation of the survey, platted to a scale of 200 feet to 1 inch. The West line of Sec. 10 is taken as a base line for the survey, and the Streets and Alleys are laid parallel with and at right angles to said base line. An iron stake 3/16 x 10 inches was driven at the corner of each lot facing the Street, and the Alley corners were marked with an iron pin 9/16 x 10 inches.  
Each Lot and Block bears its own number. The width of all Streets and Alleys and the dimension of each lot is marked on the plat in feet and decimals with black ink.
