

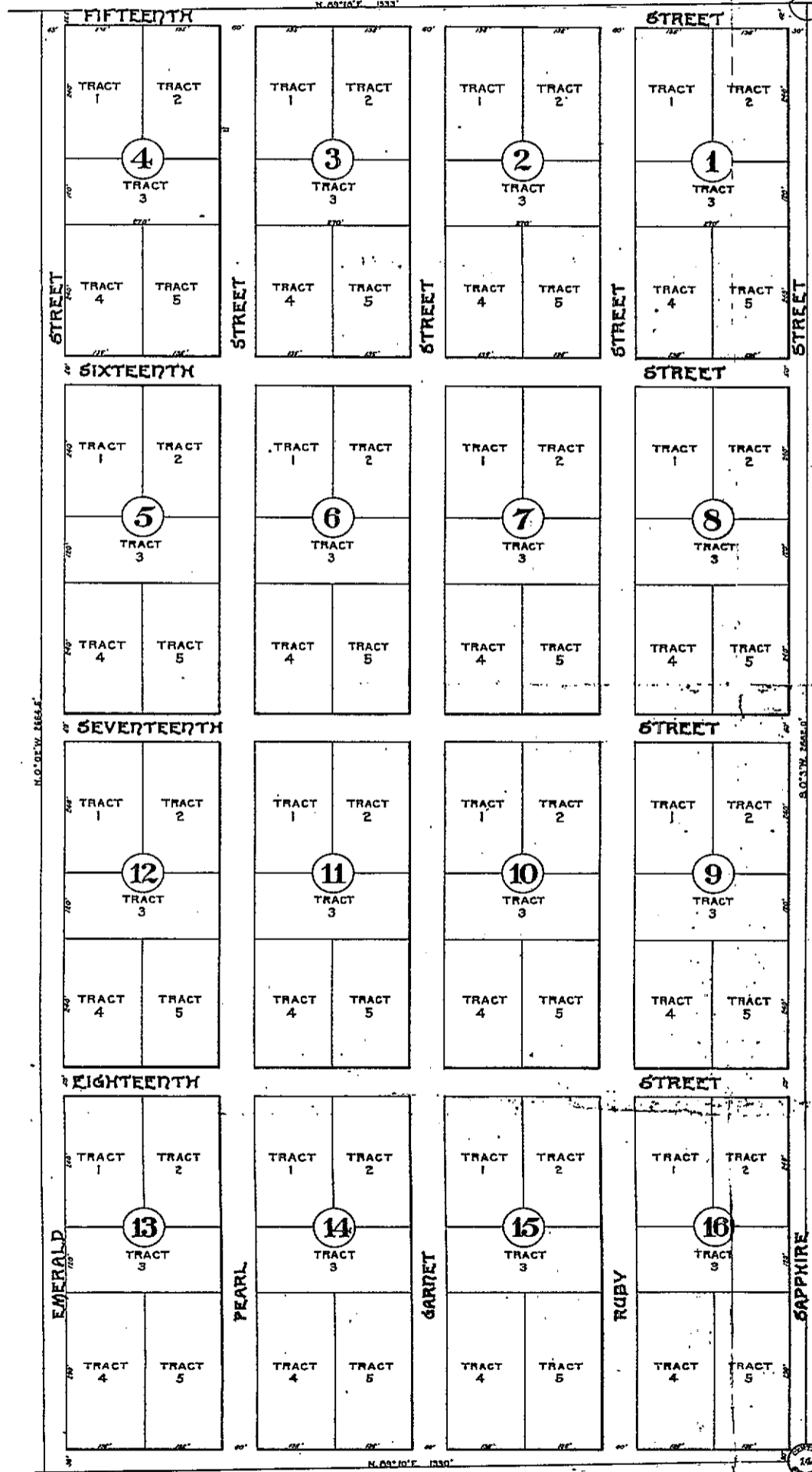

Griffith, husband and wife do hereby certify that we are the present and sole owners of eighty acres of land, more or less, situated in and being the East half (E 1/2) of the Northwest quarter (NW 1/4) of Section Fourteen, (14) Township 33 North Range 79 West of the 6th Principal Meridian situated in the County of Natrona, State of Wyoming, the subdivision of said tract of land as the same appears upon this plat is with our free consent and in accordance with our desire, and that said subdivision shall be known as CALL-HART TRACTS, addition to the City of Casper, Natrona County, Wyoming. 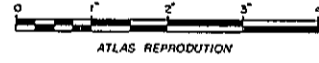
